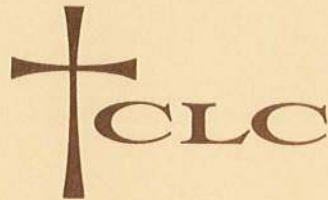

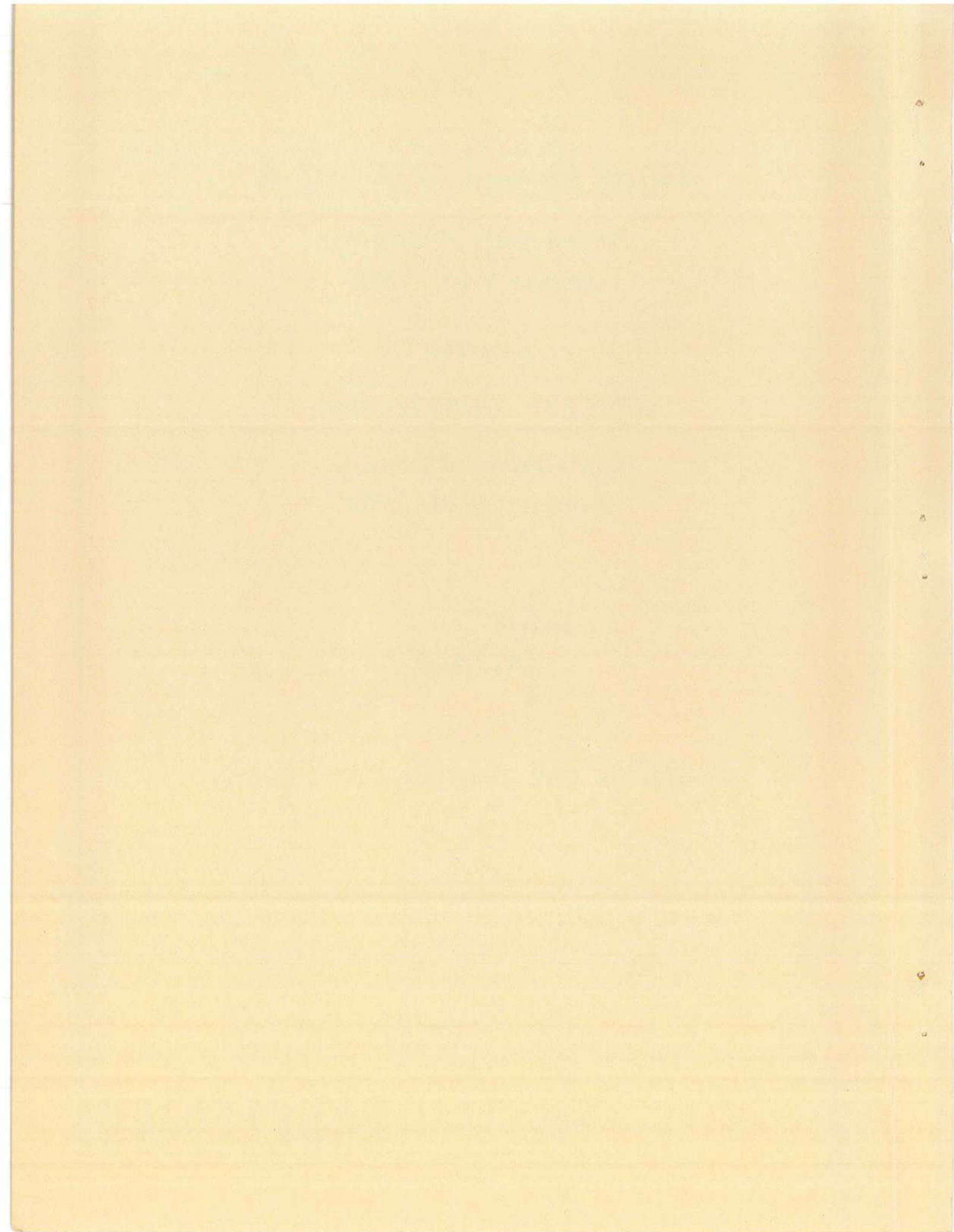

III. President's Annual Report

Jesus Christ, the same yesterday, today, and forever. Times change and the opinions and desires of men change. But our blessed and exalted Savior never changes. He is forever the same, holy and righteous, gracious and merciful. He is holy and wants us to be holy. As He was obedient in all things even unto death, so He wants us to be obedient in all things, even unto death. As He is forever righteous and holy, so He is also eternally gracious and merciful. His grace is new every morning. He has made good the promise: The mountains shall depart and the hills be removed, but my grace shall not depart from thee, neither shall the covenant of my peace be removed. In His mercy He has washed us with His own blood and has cleansed us from all unrighteousness. He has removed our sins from us as far as the East is from the West. He has cast our sins into the depth of the sea; they shall not be remembered forever. He has not only washed and cleansed us. He has covered us and adorned us with the white and spotless garment of His own perfect righteousness so that we can stand before His heavenly Father as His beloved bride, pure and holy, without spot or wrinkle.

What a source of comfort and joy for us poor sinners who deserve nothing but punishment! Jesus Christ, the holy and eternal Son of God, is our Savior, ever gracious and merciful, slow to wrath, quick to forgive, desiring only to lead us safely through this evil world so that, when our last hour shall come, we may depart in peace and joy to live with Him forever.

As our exalted Savior is forever the same, so also His commission to His believers. It is and will be until the end of time: Go ye into all the world and preach the Gospel to every creature! Teach all nations, baptizing them in the name of the Father and of the Son and of the Holy Ghost, teaching them to observe all things whatsoever I have commanded you! In short: Preach the Gospel, the glad tidings of salvation; plead with men everywhere to be reconciled with God and to come to the Father by Me.

Let us never forget that this is the only command which Christ has given, that the Gospel is the only means which He has given us to build His kingdom, the only means by which His kingdom can be built, the only means by which sinners can be saved. Every other means is foredoomed to utter failure. Let us never allow Satan to deceive us. He is perfectly willing to have us work ourselves to distraction in an effort to build Christ's kingdom and to lead sinners to repentance as long as we do not use the Gospel which is the power of God unto salvation. It is not popular to endeavor to build Christ's kingdom with nothing more than the old Gospel, but it is the only method which has our Lord's promise of blessing.

I thank my God that these eternal truths are still accepted among us without question or reservation. We have no intention or desire to engage in anything but the glorious task and privilege of proclaiming the eternal Gospel of Christ so that through it children of God and heirs of heaven may be born.

Were I to sum up the work that has been done by our Church of the Lutheran Confession during the past year I could do no better than to say that the Gospel of Christ was preached, that it was preached diligently, faithfully and truthfully, in our churches, in our schools, in every place into which the Lord called us, from the Water Wonderland of Michigan to arid Arizona, from warm and sunny Florida to the great Pacific Northwest and far off Japan.

It has been said that we are spread too thin to accomplish anything worthwhile anywhere. Leaven also is spread thin but does wonderful work nevertheless. The apostles also were spread thin. By spreading them thin the Lord of the Church quickly brought His Gospel to all the world. The Lord knows why He has spread us thin and will accomplish through us that which He pleases. Let us be faithful wherever He has placed us.

A Happy Statistic

A year ago, at our convention in Spokane, we spoke with heavy hearts of the large number of trained and gifted workers which the Lord had given us, by force of circumstance "standing idle in the market place", engaged in secular work of one kind or another. I am very happy and deeply grateful to be able to report to you that since then eight of them have been called, full time, into the vineyard of the Lord. Candidate Daniel Hanel was called to Missoula, Montana; Candidate Clifford Kuehne to Hecla, South Dakota; Mr. Henry Hasse to Winter Haven, Florida; Pastor Roland Gurgel to Cheyenne, Wyoming; Pastor John Johannes to Carlsbad, New Mexico; Pastor Keith Olmanson to Nicollet and Eagle Lake, Minnesota; Pastor Karl Brandle to Winner, South Dakota; and Miss Ruth Schaller to Mankato, Minnesota. May God speed the day when all the gifts which He has given us will be employed full time in the work of the Church.

Assignment of Calls

In the assignment of calls to candidates for the preaching and teaching ministry we have endeavored to follow the procedure to which we had become accustomed in our former affiliation. The wisdom of this procedure has been questioned. In the interest of good order and the sanctity of the call this convention ought to adopt suitable guidelines.

Immanuel congregation of Winter Haven, Florida, is bringing this matter before the convention by way of a formal memorial. This memorial has been placed into the hands of the delegates.

The Prueter Case

At the Sleepy Eye convention of the Church of the Lutheran Confession the former Pastor Paul Prueter made the charge that President Witt, the Appeals Committee and the convention itself had become guilty of misapplying Mt. 18: 15-17 and were therefore walking disorderly and not after the tradition which they had received. I am happy to be able to report that this charge has been withdrawn.

Intersynodical

The break in fraternal relations with those with whom we had been in fellowship so many years was, without a doubt, one of the saddest and most painful experiences of our lives although we were always blest and happy in the knowledge that our position was solidly grounded in the Word of God.

It has ever been our sincere hope and fervent prayer that God, through His Holy Spirit, would speedily bring our former brethren to recognize their error and thus restore complete agreement between them and us on the basis of His Word.

When the Wisconsin Evangelical Lutheran Synod in August of 1961 resolved to suspend fellowship with the Lutheran Church - Missouri Synod on the basis of Romans 16:17-18 we felt that a big step toward reestablishment of fraternal relations with our former brethren had been taken; we spoke of the suspension resolution as one "which gives rise to the hope that the membership of that Synod may be seeking to rectify a situation that has caused much grief and concern"; we said, "Over this possibility we sincerely rejoice"; and expressed the hope, "that by the grace of God eventual agreement might be effected". At the same time we defined clearly the issues that lie between Wisconsin and the Church of the Lutheran Confession: "Deviations from the Scriptural doctrine of Church-Fellowship, and the doctrine of the Clarity and Authority of the Scriptures, as well as instances of violation of the sanctity of the call".

So that all may know what has been done toward restoration of fellowship relations, we bring you, in its entirety, the correspondence that has ensued between President Oscar J. Naumann and your president.

Dear Brethren:

Since the 1961 convention of our CLC, matters have been relatively quiet for your Board of Doctrine. A further meeting was held with members of the Orthodox Lutheran Conference concerning the doctrine of Church and Ministry which, in the judgment of your committee, led to a better understanding of our position. The O.L.C. representatives stated that they would confer with their brethren about the matter. Since then this group has had a similar meeting with the Commission on Doctrinal Matters of the Wisconsin Synod and a similar agreement with that body, resulting in the announcement that with the expected agreement of their congregations they would dissolve the O.L.C. and apply individually as pastors and congregations for membership in the Wisconsin Synod.

Publication in the Lutheran Spokesman of the article on "What Separates the CLC from Wisconsin?" has led to an exchanges of letters between President Naumann and President Albrecht that — as this is written — indicates the possibility of a meeting of the respective committees within a reasonable time. Any information that may be forthcoming will be made available to our coming convention by means of a supplementary report.

The President's Report gave detailed information concerning correspondence with President Naumann of Wisconsin. Your committee considers it important that this channel of communication has been opened, and shares the view that personal discussion will be the best way of dealing with the things that lie between our respective bodies, as outlined in our Spokane resolutions: "deviations from the scriptural doctrine of Church Fellowship, and the doctrine of the Clarity and Authority of the Scriptures, as well as instances of violation of the CALL."

We regret, however, that in spite of our declared willingness to meet, no word has been received to date from the Wisconsin committee as to its plan of procedure.

MEMORIAL TO THE THIRD ANNUAL CONVENTION
THE CHURCH OF THE LUTHERAN CONFESSION
MANCHESTER, WISCONSIN
August 9-14, 1962

Whereas the public doctrine of the Church of the Lutheran Confession is in some instances in conflict with the declared doctrinal position of the church body, Article III, the undersigned, desiring that only the true doctrine of Holy Scripture shall prevail, requests that plain answers without explanations or qualifications be given to the following questions by the PRESENT CONVENTION:

1. Do you unanimously believe, teach, and confess the statement of the Augsburg Confession, Article V, "Solchen Glauben zu erlangen, hat Gott das Predigamt eingesetzt...", or, do you reject this statement? (See also Latin text of the AC which has equal authority. Triglotta 44)
2. Do you unanimously accept the statement of the Apology of the Augsburg Confession, Articles VII and VIII, which identifies the Church with the Kingdom of Christ, "Itaque ecclesia, quae vere est regnum Christi, est proprie congregatio sanctorum," or, do you reject this statement? (Triglotta 230)
3. Do you accept or reject the statement of the Smalcald Articles, Article VII, "Die Schlüsseln sind ein Amt und Gewalt, der Kirche von Christo gegeben, zu binden und zu lösen die Sünden..."? (Triglotta 492)

4. Do you unanimously accept the statement of the Smalcald Articles, Of the Power and Primacy of the Pope, IV, "Weil nun Paulus klar zeugt, er habe bei Petro nicht wollen ansuchen, dasz er ihm predigen erlaubte, auch dazumal, da er am letzten sei zu ihm gekommen, so haben wir eine gewisse Lehre, dasz das Predigtamt vom gemeinen Beruf der Apostel herkommt, und ist nicht not, dasz alle dieser einigen Person Petri Beruf oder Bestaetigung haben," or do you reject any part of this statement? (Triglotta 506)

5. Do you unanimously accept the entire content, the intent, and the terminology of the Brief Statement # 25, # 27, # 30, and # 31 as being in agreement with and as setting forth the teachings of the Holy Scriptures? Do you deem the proof texts apt and applicable? Or do you reject any part of the Brief Statement?

6. Do you unanimously agree with, or do you reject the following statements, Journal of Theology, Vol. II, No. 1, Feb. 1962, Pages 20ff. (Considering them in context, of course.)

Page 20 bottom: "...we come to realize that the entering into the kingdom of God does not specifically signify the process by which a sinner becomes a child of God. To enter into the kingdom of God does not mean to be converted or regenerated."

Page 21 middle: "The creative act by which God transports a sinner out of death into life must have preceded the state of his being in the kingdom in the sense of the passage here under consideration."

Page 22 top: "To be in God's kingdom, therefore, means nothing else than this: that through God's gracious ruling one knows that one is under this rule of Grace. In keeping with God's purpose that is the normal state of those who have entered the gracious basileia of God and Christ."

Page 24 bottom: "Whoever reaches for rank and honors in the kingdom of heaven and desires to be preferred above others is not yet therein. In the kingdom of heaven, under the Gospel rule of God, such thoughts simply do not arise. Whoever is under the sway of the Gospel rejoices in it as a child which is well aware of its weakness and inadequacy and therefore lays no claim to 'greatness'."

Your committee has met with Pastor Paul G. Koch re his memorial and unanimously accepts the confessional statements in points 1, 2, 3, 4, and 5 because we agree that these statements are the true doctrine of Holy Scripture.

WHEREAS your committee finds that further clarification of the Journal of Theology essay is needed in order to give answer to question # 6 of the Koch memorial

THEREFORE BE IT RESOLVED that a study of the essay in question be assigned for presentation to the next convention of the CLC, such study to give special regard to point # 6 of the Koch memorial.

Your committee studied at length the essay THE MEANING OF EKKLESIA IN THE NEW TESTAMENT by Pastor Paul G. Koch. We gratefully acknowledge his work.

WHEREAS we agree with the substance of the essay with the exception of the following statements (p. 4):

- 1) "In this latter usage basileia is a synonym of ekklesia and denotes in almost every instance the Communion of Saints."
- 2) "Only the use of the word 'church' for the Communion of Saints (I. In general, II. In Heaven, III. In an area on earth.) or for a local Christian congregation (the latter in a proper or improper sense) is consonant with the Holy Spirit's usage of ekklesia in the New Testament Scriptures."

BE IT THEREFORE RESOLVED: that an essay be assigned now for presentation at the next convention of the CLC re the meaning of Basileia, such study also to give special consideration to point 1 above, and

BE IT FURTHER RESOLVED: that point 2 be assigned now for further study and presentation at the next convention.

Your committee recommends that a study of all the matters assigned above be taken up at the various pastoral conferences.

E. Report of Committee # 10

Brethren:

Your committee has carefully examined the two essays entitled "ON THE RELATION OF SYNOD AND LOCAL CONGREGATION TO THE HOLY CHRISTIAN CHURCH" and "CONCERNING THE MINISTRY OF THE KEYS AND THE PUBLIC MINISTRY", and presents the following:

WHEREAS the doctrinal content of these essays has been found to be Scripturally correct and adequate, therefore we recommend that these essays be adopted as a part of the public doctrine of the CLC.

Re the memorial submitted by the Dakota-Nebraska conference to the essayist:

1. We heartily commend these brethren for their intensive interest in this confession and for the fruits of their study of this essay.
2. Your committee together with the essayist has considered the recommendations re form of theses and has found,
 - a. That there are fine suggestions with respect to logical arrangement.
 - b. That the theses, however, are more adequately expressed as submitted to and presented by the essayist.
 - c. That we therefore recommend to retain the theses in the form in which they appear in the essay.

V. MISSIONS

A. Report of the Board of Missions

Dear Brethren:

Your Mission Board has operated under a restricted or minimum budget during the past fiscal year. In presenting the needs for the next fiscal year your Board proposes full subsidy for all stations under its supervision. However, the proposed subsidies will not begin until the Convention has approved them. Therefore, the subsidies for the first two months (July and August) will be paid according to the old schedule.

The Mission Board adopted these two policies: 1) That full support be granted to a missionary, when a new mission is opened. 2) That \$10.00 per month subsidy be paid for each additional child after the fourth child.

Your Board reports the following:

1. Redeemer congregation at Cheyenne will receive full subsidy for the Pastor who is being called.
2. Messiah congregation at Milwaukee, which did not receive subsidy but was consulting with the Mission Board, decided to give full support to her Pastor, beginning March 1, 1962.
3. Upon investigation of requests the following new missions were opened: Missoula, Montana in October (Pastor D. Hanel) and Carlsbad, New Mexico in April (Pastor J. Johannes).
4. St. Paul's congregation at Winner, South Dakota, having declared itself in agreement with the CLC and having requested to become a mission of the CLC, the Mission Board concurred in a call at the end of April and decided to grant the needed subsidy to meet code salary.

Proposed subsidy for individual stations:

1. BEREIA, St. Paul: 12 communicants. Payments made by the congregation on Church-Parsonage combination - \$202.58 monthly. Present subsidy - \$140.00. Proposed subsidy - \$425.00
2. CARLSBAD, Unorganized. A group of families promised \$100.00 or more for salary and a small house for a Pastor. Proposed subsidy for salary and more adequate housing - \$325.00.
3. Gethsemane, Spokane: 50 communicants. Payments by congregation: property - \$75.00 plus interest; salary - \$50.00. Not subsidized at present. Proposed subsidy - \$285.00.
4. HOLY CROSS, Phoenix: 47 communicants; 8 pupils in school. Payments by congregation: Rent for church and school facilities - \$80.00; salaries: for Pastor - \$300.00 plus \$100.00 for house; Teacher - \$112.50 plus room and board. Present subsidy - \$112.50. Proposed subsidy - \$137.50.
5. IMMANUEL, Winter Haven: 27 communicants; 46 pupils in school. Payments: property - \$75.00 plus interest; salaries: Pastor - \$215.00; Teacher: \$225.00. Are calling second teacher to be paid from tuition; planning construction of two class rooms (c. \$7000.00). Present subsidy - \$200.00. Proposed subsidy - \$410.00.

6. MISSOULA, Montana: Unorganized. 16 communicants. Payments: rent for church facilities - \$60.00; Salary \$70.00. Present subsidy - \$205.00. Proposed subsidy - \$225.00.

7. MONROE, Michigan: Group promised \$60.00 and housing. Intend to call. Subsidy proposed - \$265.00.

8. REDEEMER, Cheyenne: 45 communicants; 28 pupils in school. Payments by congregation: property - \$110.00; Pastor - \$50.00; Teacher - \$150.00; Second teacher - \$50.00. Present subsidy - \$107.00. Proposed (for Pastor and one teacher) - \$550.00.

9. REDEMPTION, Seattle: 12 communicants. Congregation pays \$50.00 salary and \$95.00 house rent. Present subsidy - \$217.00. Proposed subsidy - \$285.00.

10. ST. PAUL'S, Winner, South Dakota: About 50 communicants. Congregation pays \$200.00 salary. Proposed subsidy - \$200.00.

11. ST. PETER'S, Denver: 21 communicants. Payments by congregation: property - \$147.84; salary - \$30.00. Present subsidy - \$168.00. Proposed subsidy - \$395.00.

12. NEW MISSION: Amount proposed in budget - \$400.00.

JAPAN: The work in this field has progressed under the Lord's guidance and with His blessing. Missionary Tiefel and the Japanese Christians are taking steps for the legal organization of the Japanese Church. Pastor Tiefel reported with great disappointment that Mr. Sano, after a period of theological training, has decided not to prepare for the public ministry. He plans to seek employment when health permits and will continue to help in the general work of the church. A more complete report will be submitted to the Convention, when Pastor Tiefel, D.V., will be among us.

C. Supplementary Report - Board of Missions

To the CLC Convention, assembled at Manchester, Wisconsin, Aug., 1962

Brethren:

As a supplementary report on the Japanese Church you Board of Missions brings you a direct word from its members, namely the minutes of their meeting. The translation of the minutes, submitted by Pastor Fred Tiefel, follows:

Hachiman - Dori Ev. Lutheran Church
Tokyo, Japan
July 18, 1962, 7:00 p.m.

1. Meeting is opened by Chairman Yamanaka with prayer for the Holy Spirit's guidance.
2. All members present except those that had been excused previously.
3. To the new members (two) present, the doctrine of the divine call into the public ministry is reviewed by chairman Yamanaka. Discussion of Pastor Tiefel's call in Feb. 1957 by the Japanese Lutheran Church is ratified by all those present including the new members. The resolution of the CLC expressing desire to call a second foreign missionary for Japan is discussed. Chr. Yamanaka explains to the two new members that the congregation has moral and financial responsibility for their called pastor. He explains the amount of financial aid that is being presently received from the Christians in America.
An explanation (requested) at this point is given by the pastor for the reception by baptism into membership on the part of a young lady who had not attended the regular instruction class during the past two years like the others. Pastor Tiefel explains that special classes were requested and held for the young lady. In proof of her sincere desire to be baptized we see her withdrawal from the Buddhistic Society of Soka Gakkai. Everyone agrees that she may expect persecution from her family and friends. We pray that the Holy Spirit may abide with and comfort her by her baptism. Her face showed great joy and peace after receiving baptism.
4. The sermons prepared by Pastor Tiefel for the Sundays until Oct. 14th are distributed and assigned by Chr. Yamanaka. Pastor Tiefel states that he will try to return from the States by the middle of September. In emergency he promises to return by the first plane with which he can make connections. The first two Sundays in August the congregation and its preachers will take vacation.

5. Chr. Yamanaka reintroduces the discussion concerning a second foreign missionary from the CLC. The following sentiments are expressed:
 - a. The sending of a second man does not appear to be urgent.
 - b. If services are requested in another place or city, a leave of absence can be arranged for our pastor. The members here can conduct services, Sunday School and Bible classes.
 - c. It would seem appropriate that we ask the CLC brethren to pray with thanksgiving for the continued health and long years of service of our pastor. We so pray.
 - d. Are not the Japanese Christians responsible for the mission expansion work in Japan? This is a question raised by one of the members.
 - e. Of course, if the CLC wishes to send one or more foreign mission personnel at this time, we would extend fellowship, aid, advice, and spiritual supervision. But it would be, in such case, not at our request at this time.

Conclusion: We do not consider the sending of another foreigner as a missionary urgent at this time.

6. Chr. Yamanaka introduces the subject of organizational membership with the CLC. He explains to the new members that organizational membership would require our incorporation papers to be so written that it would indicate that we are a legal part of the Stateside Church, subject to the legal provisions and directions of an American incorporated body. The disadvantages of this arrangement in case of political disturbance on either side, or a deterioration of doctrine in Americas, or the uniting of the CLC with other church bodies, our inability to be adequately represented for voting on the affairs of the American incorporation are some of the factors discussed. The following sentiments are unanimously approved:
 - a. All members advise against external, legal, organizational integration with the legal incorporation of the CLC.
 - b. All members desire unity of the spirit to be maintained and fostered with the Christians of the CLC.
 - c. All members are deeply appreciative of the financial aid given by the Christians for the CLC.
 - d. The equity of the CLC beginning with Jan. 1961 to the amount of \$150.00 per month has been previously recongnized. It is our intention to assume these payments on the contract signed by this congregation and its pastor with the Wisconsin Synod as soon as possible, thereby reducing the subsidy from the CLC by the \$150.00 per month.
 - e. The balance of the subsidy granted we wish to consider a debt repayable to others (as we grow) i. e. repayable by doing mission work in the other parts of Japan and Asia, and wherever the Lord of the Church may lead us. In principle we deem it wise to say that grants-in-aid to fellow-Asians must not be conditioned upon or imply organizational or external direction from Japan. Such a condition (attached to grant-in-aid) would not only alienate, but also hinder the development of native leadership, judgment, and the gifts of God.

Our goal, assuming the future privilege of proclaiming the Gospel to our fellow Asians, must be to let the fellow Asian develop his own external and organizational expression of his faith in Christ. Only we would seek to maintain an intimate degree of confessional church fellowship in the realm of public doctrine and practice, exchange teaching material and techniques, exchange delegates, welcome and send visitations for maintaining doctrinal unity as sister churches in Christ.

- f. Pastor Tiefel is instructed to thank the CLC most cordially for the aid rendered to us, both financial and spiritual. We pray the Lord of the Church to bless them for such sharing. He is furthermore requested to present our conception of a wise and edifying administrative policy for foreign mission work at least in Japan.

We on our part must work more zealously as individuals and as a congregation, and assume our privilege of hearing the Gospel and the cost thereof. By the grace and mercy of God we wish to free the CLC as soon as possible of the financial burden of assisting the work in Japan, so that its potential may be directed to other countries of the world in which a true witness to the Gospel is lacking. We pray that the Holy Spirit open the doors of these countries now lacking a voice of the true Gospel by divine calls into those benighted lands.

7. We pray that the Lord Jesus grant health, strength and wisdom to our pastor, so that his attendance at the CLC Convention may edify and profit the Church of Christ.
8. We authorize and urge, if possible, that Mr. Shigeta attend the Convention from New York on Saturday and Sunday, if he can obtain leave from his business. Our pastor states that he will try to arrange to meet him at the Milwaukee airport on Saturday a. m. and return him to the airport on Sunday p. m.
9. We regret that the plans of Mr. Kitaoka, who is now on business in San Diego, to attend the CLC Convention was prevented by the Lord of the Church. We await his safe return from the States.
10. If Mr. Shigeta moves to New York on a permanent basis, he is urged to preach the Gospel to those interested in the Japanese community in the circle of acquaintance, and to conduct Sunday School classes if feasible especially for the Noda family and their children and Mr. Shigeta's own family when they join him. He will be provided with Japanese Sunday School lessons and sermons by us, or the English equivalent.
11. These and all other matters, and the welfare of all our fellow-saints everywhere we commend into the hands of our Savior, who commanded us to pray... (Close with the Lord's Prayer)

4. We would consider the investment of any funds on our part in the Japan mission fully repaid by its intended efforts to do mission work in other parts of Japan, Asia and wherever the Lord of the Church would lead them.

D. Report of Committee #4

Concerning our Japanese mission, we concur with the thinking of our Board of Missions as follows:

1. We concur with the Japanese Christians that the sending of a second man does not appear urgent at this time; however, we recommend that our Mission Board continue to consider the question of providing for a second man for our Japanese mission so the best interests of our missionary, the Japanese brethren, and the CLC be served.

2. We rejoice over the fact that the Japanese Christians so clearly see that the legal organizational ties are of less importance and significance and that, rather, they stress the fact that they are one with us in Christ on the basis of God's Word.

3. We commend the Japanese Christians for their zeal for wanting to acquire legal title to the property and are happy to hear that they are ready to assume the responsibility of \$150.00 per month property payments as soon as possible.

4. We would consider the investment of any funds on our part in the Japan mission fully repaid by its intended efforts to do mission work in other parts of Japan, Asia and wherever the Lord of the Church would lead them.

5. We recommend that our body comply with the request of Pastor Tiefel and his congregation for a Board of Review for the materials they wish to put into final print. The Board of Doctrine shall serve as the Board of Review.

6. We are encouraged by the statistical report on the work in the Japanese field and commend Pastor Tiefel and his congregation for their labors in making the Word of God available to the Japanese in their native tongue.

ACTION BY THE CONVENTION: ADOPTED

E. Report of Committee #8

Suggested Regulations

1. Loans from the Church Extension Fund shall be granted only to congregations which are under the supervision of the Mission Board.
2. Loans shall be granted only for land and for buildings which serve as churches and/or schools.
3. Applications for loans shall be made by the local congregation to the Board of Missions, or by the Board of Missions itself; regarding plans, specifications and contract terms the Board of Missions and the Board of Trustees shall act in consultation with each other.
4. a. Title to the property shall be vested in the CLC until a transfer of title can be arranged.
b. As soon as there is an organized congregation, an agreement shall be made concerning the property.

5. Loan payments need not begin until one year after the completion of construction. These payments shall be in quarterly installments according to a schedule arrived at by the Board of Missions in consultation with the congregation, subject to the approval of the Board of Trustees. See By-Laws 2, B, 3.

6. Unused Church Extension Funds may be placed in short-term investments by the Board of Trustees.

VI. EDUCATION

A. Report of Acting President of Immanuel Lutheran College

Dear Brethren:

By the grace of God, Immanuel Lutheran College is about to bring to a close its third year of operation, a most successful year, all things considered.

Each of the three departments has done its respective part. With an enrollment of sixty-two students, the High School will D.v., graduate a class of eleven. The College Department has twenty-two students, one of whom will graduate from the four-year course so far in effect. The Seminary has six students, with one to graduate.

The two additional professors granted in 1961 have so far enabled us to increase our full-time facilities to two classes of the college department, Freshman and Sophomore. Junior and Senior students in this department have continued to take secular subjects at State College, with supplementary instruction in subjects essential to our work being supplied by our own staff. The extending of a permanent call to Professor C. M. Gullerud as instructor in theology has stabilized a situation that began as an emergency measure and has so far extended over a period of two years.

Plans for the new schoolyear to begin next September include an extension of our courses offered, allowing for a third year course in education that can be completed by a minimum use of State College facilities. This extension of courses offered has been achieved without addition to our faculty or plant facilities.

WE ASK that these arrangements be approved, tentatively by the Co-ordinating Council, and eventually by the Convention of our Church of The Lutheran Confession.

WE FURTHER ASK that while this arrangement is in effect students completing our three-year pre-Theological course be admitted to our Theological Seminary, and that students completing this new three-year course in education be considered eligible for call into the schools of our CLC, with the proviso that those desiring to qualify for a State Certificate may do so at any State School of their choice.

Arrangements for a course in typing and general business practice are also being made. This course is to be offered on a fee basis, with the students supplying their own machines. Instruction will be by a non-faculty instructor, and will be without cost to the CLC.

WE ALSO ASK for the approval of this arrangement.

Our most serious problem at this time is the housing of out-of-town students. There will be a special report on this subject.

D. Student Housing Report.

Dear Brethern:

The Housing Committee is pleased to present the following report of success of the Housing Program of ILC. We realize that our Lord has given ample blessings upon our labors, and cause for thanksgiving. All students enrolled at ILC for the 1961-1962 schoolyear have been provided with adequate housing in homes of members of Immanuel Congregation, or in dormitories operated by members of Immanuel Congregation.

With the present facilities we are housing fifty-four students in seventeen units comprising two boys' dorms and fifteen other dwellings. These scattered facilities have caused some supervisory problems and some financial stresses. One boys' dorm changed hands during February and is suffering some financial distress at present. To alleviate this problem the board will be bringing its own recommendations. The policy of the Housing Committee in regard to the two dorms is that they be self-supporting. Experience has shown that this is not always workable. We are therefore recommending that the board and room rate be increased.

The present housing units handle only present enrollment. Information at hand to date, considering decreases in present student body from the high school, as well as assrual into the college department reveals that the present facilities will be completely filled again next year, without allowing for normal enrollment growth.

If the Lord grants us this desirable normal growth, as we pray that He may allow us to prepare more laborers for His harvest, our housing facilities must be enlarged forthe 1962-1963 schoolyear. Without such enlargement we will be forced to restrict enrollment of such students from congregations of the CLC which are not within daily driving distance of the school. Such a development would not serve the interest of ILC or the CLC.

The two boy's dorms are operated as a private business venture of the house parents, under policy control of the Housing Committee of ILC. It is evident that this arrangement dare not be considered a permanent solution to the housing problems. The locating of another rented dwelling large enough to be used as a dorm for approximately one dozen students is an acute problem in Mankato, as well as the acquiring of dedicated, gifted, and capable house parents. Since the very life of our school is so acutely dependent upon the success of our housing program, it must be considered a gift of God's grace that our emergency solutions have fared as well as they have.

From the view points of policy and finances, also bearing in mind that the two leases will expire at the end of May 1963, a more satisfactory plan for student housing should be inaugurated at the present time, so that proper action toward a more permanent solution may be taken by the August Convention of the CLC.

The Board of Regents has been authorized by the Co-ordinating Council to investigate the cost and involvements of providing a thirty to forty student housing unit and report the same to the 1962 August Convention of the CLC.

E. Report of The Planning Committee.

At the Second Annual Convention of The Church of The Lutheran Confession, which was held at Spokane, Washington, the body resolved that "since the present location of the ILC would be inadequate for future expansion, Be it resolved that a Planning Committee be elected to begin planning for the relocation of our school at permanent sites." President Paul Albrecht directed the Committee at the first meeting as to the scope of the assignment. Among other things it was made clear that this Committee was not to function as a "policy committee" determining whether the ILC should continue as one unit on one campus or whether the ILC should be divided into two or more units on more than one campus.

In response to the appeal of the Committee for information and suggestions for sites in various cities and areas where the CLC is represented, the following proposals were made for the consideration of the Planning Committee.

EAU CLAIRE, WISCONSIN. Twenty acres within the city limits on an elevated portion of ground which overlooks the Chippewa Valley, about 3-1/2 miles from city center, with bus service and with all necessary utilities as water, electricity, disposal facilities available. This property is adjacent to Messiah Lutheran Church property. The cost would be about \$4,000.00.

MANKATO, MINNESOTA. Four locations were suggested. Two sites were eliminated because of a lack of sufficient information.

THE DORING PROPERTY. Twenty acres about 4 miles out of the city and outside of the city limits. This property is next to Minneopa Park. It is a choice piece of property overlooking the Minnesota River Valley. No utilities are near the property at this time. The owner has been offered over \$40,000.00 for this piece of ground. He is offering it to us for \$20,000.00.

THE MIDWEST REALTY PROPERTY. Thirty lots (about 7 acres). This property is sub-divided. Curbing and paving are on streets surrounding the property. Utilities are available. This property is not too far from Mankato State College. The cost would be \$60,000.00.

RED WING, MINNESOTA. Two Locations were proposed.

THE CHARLSON PROPERTY. Thirteen acres. This property is about 4

miles from Red Wing, and about 1 mile off the main highway. The location is view property. Electric lines come into the property, but other utilities would have to be provided. A 400 foot well and a self-contained disposal unit would be necessary. The cost of the property would be \$7,800.00. This is a generous figure considering the location and favorable features.

THE FITSCHEN PROPERTY. Ten acres at \$1.00 with additional adjacent acreage available at a reasonable price. This location is about 4 miles from the city and less than a mile from a principle highway. It is very attractive as view property overlooking a lake and The Mississippi River Valley. Utilities except for electricity would have to be provided. A well at least 400 feet deep would be necessary. Mr. Fitschen has offered this acreage as a gift if it can be used as a site for the ILC.

WATERTOWN, SOUTH DAKOTA. Four sites in the vicinity of Watertown were proposed. One site, about two blocks from the city limits, was offered for \$600.00 per acre. Since the property is outside of the city limits, it was eliminated from our consideration. It was felt that Watertown was too far away from the majority of our larger congregations.

Your Planning Committee met three times to consider various sites. We hope to meet once more before the August Convention and we hope to provide a supplement to this report and recommendation.

Various factors were taken into consideration in making our recommendation. Existing Church facilities, transportation, general location in relation to the present constituency of the CLC, the cost of the property and the development of it, and some of the problems in relation to the transplanting of the educational institution. We found that property which had no utilities would be too expensive. It was estimated that a self-contained disposal unit would cost anywhere from \$30,000 to \$60,000. It would cost about \$18.00 per foot to drill a well plus the pump and pressure tank. The water system would cost between \$10,000 and \$20,000, depending on the location. Your Planning Committee was aware of the reason for the assignment at this time, namely, because the existing facilities were deemed inadequate for future expansion.

On the basis of the proposals before the Committee at this time, we feel that the only realistic action presently within the reach of the CLC is the purchase of the property in Eau Claire, Wisconsin.

Your Planning Committee therefore recommends to the Convention the purchase of plots #11-960 and the Eastern half of plot #11-969 for \$4,000.00.

F. Supplementary Report, Board of Regents

Re: Student Housing

Your Prospectus, Report of Immanuel Lutheran College, Student Housing, page 4 states that "our housing facilities must be enlarged for the 1962-63 schoolyear...a more satisfactory plan for student housing should be inaugurated at the present time, so that proper action toward a more permanent solution may be taken by the August Convention of the CLC. The Board of Regents has been authorized by the Co-ordinating Council to investigate the cost and involvement of providing a thirty to forty student housing unit and report the same to the 1962 August convention of the CLC".

The investigation for a student housing unit came about in response to an emergency housing need which must be faced in view of the '62-'63 schoolyear. We report the following developments:

1. This need for a dormitory remains urgent, although we have temporary relief in the use of a rented home for a girls' dormitory. This relief, however, is no solution for the '63-'64 schoolyear, since at least one of the present rented dormitory homes may be torn down (by the owners, not by our students). It should be noted that the 1963 CLC convention presents a late date in providing a solution for the '63-'64 dormitory accommodations.
2. In accord with the Co-ordinating Council's authorization, your Board of Regents has made an investigation and has gathered information concerning possible local solutions to the unit housing of thirty to forty students.
 - A. The purchase of an available apartment house (marketable property).
 - B. Construction of a steel span-type building.
3. Your Board of Regents has not prepared a specific recommendation with regard to either of these solutions, since it seems to them that the one consideration over all is the designation of an ILC campus are by the CLC. Without designating specific land for purchase at this time, a decision ought to be made at this convention either as to where the CLC will desire to locate the permanent ILC campus, or to continue at Mankato at the present place for the present time. Your Board feels that this primary consideration must serve as the basis for making a practical recommendation concerning either temporary or permanent student housing.

G. Report of Committee # 5.

Re: Student Housing Report, Prospectus page 3; Report of the Planning Committee, Prospectus, page 11; Supplementary Report, Board of Regents, Student Housing and Special Memorandum.

Since these reports are interrelated, we considered them together and present four recommendations.

1. We recommend that the convention elect a committee of five, 3 pastors and two laymen, to make a study of a policy to be followed by the CLC in regard to Immanuel Lutheran College, as to whether the three departments should remain as a unit or be divided, and present recommendations to the next convention of the CLC.

We recommend that the Nominating Committee present the slate of candidates for the election of this committee.

2. We recommend that the present Planning Committee be continued, ready to function when the policy matter has been decided.

3. We recommend that the Board of Trustees carry out suggestion A of the Board of Regents (Supplementary Report, Board of Regents), "The purchase of an available apartment house (marketable property)," upon approval of such a purchase by the Co-ordinating Council.

4. We recommend that the Board of Trustees purchase an investment, with a portion of the Bequest for ILC, the Eau Claire property mentioned in the Planning Committee report. This purchase is not to be in any way construed as committing the CLC to a policy regarding Immanuel Lutheran College.

ACTION BY THE CONVENTION: ADOPTED

H. Supplementary Report, Board of Regents

Re: Scholarship Fund

Since some promising students may be discouraged from enrolling at ILC because of lack of funds, we recommend the following:

A) That congregations of the CLC be encouraged to sponsor students with financial aid in such cases where personal resources may be inadequate.

B) That a scholarship fund be established at ILC. Congregations and individuals would be encouraged to use this fund for special gifts, especially in such cases where a similar fund is not maintained in the congregation. The ILC scholarship fund would be administered by the faculty according to regulations approved by the Board of Regents.

This recommendation is prompted by the fact that definite cases of need have arisen. There is, at present, no established policy for dealing with such cases of need. It is our hope that such provisions might be made without increasing the budgetary requirements for operation of the school.

I. Report of Committee # 5

Re: Supplementary Report, Board of Regents - Scholarship Fund.

We recommend that the name of this fund be changed to Student Aid Fund.

We recommend adoption of A) "That congregations of the CLC be encouraged to sponsor students with financial aid in such cases where personal resources may be inadequate."

We recommend adoption of B) with this change in the first sentence: That a fund be established at ILC for either special grants or loans to students. To be consistent a further change in wording would be necessary in the last sentence. Substitute This for The ILC scholarship.

ACTION BY THE CONVENTION: ADOPTED

J. Supplementary Report of the Planning Committee of the CLC

We recommend that a letter of appreciation be sent to Mr. Fitschen and that letters of appreciation be sent to the pastors of the other men who made offers of property; the pastors in turn would pass the word along to the members involved in each case.

VII. CLC BOOK HOUSE AND PERIODICALS

A. Report of the Committee of Control for the CLC Book House

In regard to organization, your board has engaged Pastor Rollin Reim as manager of the CLC Book House. We have given the establishment the name "CLC Book House" (Owned and operated by the Church of the Lutheran Confession). There has risen the need for some part-time help and this need has been filled by the acquiring of a press operator to assist Pastor Reim, and a mechanic to service the press. These men are employed at the rate of \$1.50 per hour. To help with some of the layout and composition work, Mrs. Rollin Reim has been employed part-time at the hourly rate of \$1.25. The manager's salary is \$125 per month bringing his total wage up to scale. A branch office has been set up at ILC. Rental of equipment, housing of such equipment, heat, light, insurance, etc. has been set at the monthly rate of \$30.

Our major purpose is to serve the CLC by fulfilling their printing needs and making church supplies available to its constituency. However, we do feel that the availability of visual aid material, office equipment, duplicating supplies, and the like is advisable.

For an example of the activity and amount of business transacted at the Book House note the accompanying financial statement.

As the facts and figures show, the demand upon the facilities of the Book House has been great and for this we are appreciative. To date we have been doing work that on the open market would have cost various departments of the CLC up to 40% more. Some of these policies will have to be reviewed at this time. To date the Book House has operated without incurring any indebtedness. The original capital investment of the CLC of \$1000 has been used for the purchase of a composing machine and inventory.

We do not believe that we can continue to keep a manager-operator combined at the present rate of \$125 per month. We dare not hope to continue to employ an experienced press operator, even part-time, at the rate of \$1.50 per hour. We do not deem it advisable nor good stewardship to store a rented piece of equipment.

At the present time we are not thinking in terms of an outright cash purchase of the equipment (\$3000.00, 75% of value), but we do feel that the CLC should purchase the equipment and assume responsibility for the proper operation of such equipment. Towards this end, we would suggest at this time that the CLC invest \$250 per month. This amount along with a realistic increase in price schedule for CLC printing and saleable materials would offer the hope of a debt free printing and publishing establishment, with proper operation, within the next three years.

We further suggest:

1. Consent to engage a full-time operator.

2. That the CLC through its Board of Trustees decide whether or not to incorporate the Book House, thus giving permission to incur indebtedness.
3. That the CLC arrive at some measure of consistency as to who shall be responsible for authorizing publications other than periodicals and work commissioned by the administration.
4. That the CLC urge all its members to gain the habit of using the Book House at every opportunity, planning well in advance that we may give you all our best service.

F. Report of Lutheran Spokesman

The editor of the Spokesman has been released from his pastorate to devote more time and energy to this publication. He is now residing at Denver, Colorado, where he has secular employment.

This should make it possible to begin semi-monthly publication of the Spokesman in September, 1962. The present subscription list is 1650 individual subscribers and about 100 in bundles. If the subscription price is increased to \$2.00 for blanket subscriptions and \$2.50 for individual subscriptions, the income would be about \$3600 per year. The cost of a semi-monthly publication will be about \$4500 per year. It is hoped the subscriptions can be increased to 2000 which would be enough to meet expenses. Since this is not yet a fact, the Church of the Lutheran Confession is asked to be ready to subsidize the Spokesman, if necessary.

There is a pressing need to have annual meetings for writing workshops for the contributors and editors of the Spokesman. These should be two-day meetings devoted entirely to planning and improving the Spokesman as well as to mutual encouragement and advice. The cost of these meetings would be about \$500.

The convention is asked to include \$1000 in its budget for the Spokesman: \$500 anticipated subsidy; \$500 for a meeting of the contributors.

VIII. CONSTITUTION

A. Report of the Standing Committee on Constitution

Note: The following report of the Standing Constitution Committee are here as they were presented to the convention, not necessarily as they were passed. The actual action that was taken on constitutional matters will appear in the report of floor committee # 7.

ARTICLE IV: Membership

We recommend adoption of Article IV, Section B, Paragraphs 1 and 3.

We recommend that Paragraph 2 of this same Section B be amended to read as follows:

Voting privileges at conventions shall be granted to accredited delegates of each congregation holding voting membership and to pastors, professors and male teachers holding voting membership. Each congregation of hundred communicants or less shall be entitled to one delegate. Larger congregations shall be entitled to an additional delegate.

ARTICLE V: Officers

We recommend that Article V, Section A, Paragraph 5 be amended to read as follows:

5. The president shall be available for counseling when called upon by members of the organization, i. e. pastors, professors, teachers, and congregations. The president is assisted in this work by the conference visitor to whom these particular duties have been entrusted on a conference level. Individuals and groups within congregations are to seek counsel from their respective pastors, but may appeal to the president in disciplinary cases as outlined in Article VIII, Section B.

We recommend that a new paragraph be appended to Article V, listed as follows:

The conference visitor shall be a pastor elected by his respective delegate conference for a period of two years, subject to the approval of the subsequent convention.

The duties of the conference visitor shall be:

1. He shall represent the president at his request, particularly with respect to the duties of the president referred to in Article V, A, Paragraphs 2 and 5.
2. He shall make his services available to pastors and teachers of the Word who desire to seek his counsel and encouragement in the discharge of their official duties and the problems of their personal life.

3. He shall give attention to exhortation and the need of correction where instances of pastoral laxity or of doctrinal or moral aberrations on the part of the clergy come to his attention in a manner orderly and consonant with provisions of Holy Scripture (Matthew 18:15).
4. In the discharge of his responsibilities he shall counsel with the president in matters affecting the common welfare of the body and shall be held to refer any disciplinary needs within his jurisdiction to the office entrusted with such affairs under Section B of Article VIII.

ARTICLE VI: Boards and Committees

We recommend that the first paragraph of Section 4. Board of Trustees be amended as follows:

The board of trustees shall be elected by the body as its legal representative and have sole authority to execute all legal documents and make disbursements according to the directives of the convention. Requests for extra-budgetary or deficiency appropriations shall be directed to the president, who shall have authority to allow these requests in consultation with the vice president or with the coordinating council, if this is possible.

We recommend the deletion of the last sentence of the first paragraph under the title, General Duties of the Boards in Article VI.

ARTICLE VII: Conventions

We recommend that Article VII, Paragraph 3 be deleted, especially in view of the adoption of Article IV, Section B.

ARTICLE VIII: Supervision and Discipline

We recommend that Paragraph 2 of Section A read as follows (in view of the fact that provision has been made for the visitors):

2. The office of the President shall be specifically charged with the supervision of the public teaching and preaching of the Word within the membership of this body. In its behalf the President shall take all proper measures to insure the maintenance of the public doctrine and practice of this body in conformity with its official confessions.

We further recommend the deletion of the second paragraph under Point 4 of ARTICLE VIII since the content of this paragraph has been incorporated in the paragraphs listing the duties of the visitor, Article V.

ARTICLE IX: Amendments

We recommend that the following sentence be added to Section B:

The convention may edit properly-submitted amendments provided the intent of the amendment is not altered.

BY-LAWS

We recommend that 1. Board of Doctrine be revised to read as follows:

The Board of Doctrine shall be composed of four members, to be elected at each regular convention.

We recommend the following addition to the first paragraph of Section 6. Call Committee:

The president and secretary of the Board of Regents shall be the chairman and secretary respectively of the Call Committee.

We recommend that Section 7. Budget Committee be revised to read as follows:

The body shall have a Budget Committee which shall consist of the executive committees of the Board of Regents, Board of Missions, and the Board of Trustees. This committee shall propose the annual budget which shall be presented to the convention for action. The chairman of the Board of Trustees shall be chairman of the Budget Committee.

We propose the following new By-Laws:

10. Definition of Ex-officio

The term, ex-officio, as applied to the president in reference to his attendance at board and committee meetings shall mean that he has all privileges of membership on elected boards and committees, including voting, but without their duties and responsibilities.

11. Statistician

The statistician shall be appointed by the president. He shall make a statistical survey of the body and report at each convention.

12. Archivist

The archivist shall be appointed by the president. He shall collect and preserve the necessary documents of the body.

13. Co-ordinating Council

The co-ordinating council shall consist of the executive committees of the Board of Trustees, Board of Regents, and Board of Missions. It shall also include: 1) the editor of the Spokesman, 2) the editor of the JOURNAL, 3) the president of ILC, 4) the moderator, 5) the vice-president, 6) a representative of the Board of Education, 7) a representative of the Board of Doctrine, 8) the chairman of the committee of control of the CLC Book House, 9) the visitor of any conference not already represented on the Council.

The primary fundtion of the co-ordinating council shall be to co-ordinate the work of the various boards of the body.

The co-ordinating council shall be of all possible encouragement to the president, and to one another, in the furtherance of the work of the affiliated congregations as it is undertaken by the organized body.

B. Supplementary Report of the Standing Committee

Your committee wishes to clarify its recommendations in regard to ARTICLE VI: Boards and Committees, Section 4. Board of Trustees. Our recommendation is that this entire section read as follows:

The board of trustees shall be elected by the body as its legal representative and have sole authority to execute all legal documents and make disbursements according to the directives of the convention.

Requests for extra-budgetary or deficiency appropriations shall be directed to the president, who shall have authority to allow these requests in consultation with the vice president or with the co-ordinating council if this is possible.

The board of trustees shall appoint a treasurer who need not be a member of said board and who shall not hold any other elective office in the body during his tenure of office. This treasurer shall be known as the treasurer of the corporate body; he shall receive and disburse all funds according to instructions and give an annual report to the convention.

Your committee recommends that By-Law 4. Board of Trustees, A. Composition read as follows:

The board of trustees shall be made up in the ratio of three pastors and three laymen. The members of the board of trustees shall not be members of any other board. The term of individual members shall be six years. The board shall be elected in such a manner that the term of one-third of its membership expires every two years.

The change is that the last two sentences were shifted from the Constitution to the By-Laws.

The following memorial relating to placement of graduates has been directed to your standing committee on constitution:

- Whereas assignment committees for the placement of graduates are of human establishment and without precedent in Scripture; and,
 Whereas assignment committees in former synods abused their authority and contributed to the violation of divine calls; and,
 Whereas the direct calling of pastors or teachers by the local congregation has the precedent of Scripture (Acts 6:2-6; 14:23; 2 Cor. 8:19); and,
 Whereas our Lutheran Confessions declare that "it is necessary for the Church (die Kirchen, i. e. congregations) to retain the authority to call, elect and ordain ministers" (Smalcald Articles, Trigl. 523, 67);
 Resolved that Immanuel congregation, Winter Haven, Florida, respectfully request that instead of an assignment committee the CLC would establish a candidate information committee, with the following duties:
- 1) To transmit information on candidates to calling congregations by April 1st; and
 - 2) To assign candidates only when authorized to do so by a calling congregation.

COMMITTEE ON GRADUATES

The committee on graduates shall be composed of a sub-committee of the co-ordinating council, augmented by representatives of the faculties concerned with recommending the respective candidates. This committee shall consist of one representative of each conference, and it shall be elected by the co-ordinating council. The president of the CLC shall serve as chairman of this committee, and correspondence shall be directed to him.

Congregations and boards wishing to call graduates are requested to make their needs and wishes known to this committee at an early date. So that the needs of all may be considered and supplied as well as appears possible, congregations and boards are requested to use the services of this committee in exercising their right to call graduates into the ministry. It is mutually understood and agreed that the assistance given by this committee does not constitute an assignment of a given graduate to a certain field; its work is to expedite calls (issued by those empowered by God to perform this sacred act), directing them to persons whose service in a particular field appears best to serve the needs of the whole cooperating church.

When the committee on graduates has directed a call to a candidate, it shall forward to the calling congregation information regarding the candidate. The congregation will then extend the call.

The committee on constitution also proposes the following addition to point 13 of the Report of the Standing Committee on Constitution, May 6, 1962. The following sentence is to be added to the first full paragraph:

"The president of the CLC shall call and preside at the meetings of the co-ordinating council." cf. Art. V, A-6.

The sentence is understood by the committee not to be a substantial addition to the constitution, since we had felt it was already covered in Art. V, A-6. We merely add it here for clarification.

D. Report of Committee # 7

1. We recommend that the standing committee on constitutional matters formulate a By-Law providing for the review of the minutes of pastoral and delegate conference by the conventions of the CLC.

2. We recommend adoption of the following report:

Whereas the church body to which the preparation of candidates for the preaching and teaching ministry has been entrusted, is qualified to advise in the placing of these candidates, and

Whereas Christian love and good order involve proper regard for the needs of the entire body, be it

Resolved that the following provision be made a By-Law to the Constitution of the CLC:

COMMITTEE ON GRADUATES

The committee on graduates shall be composed of the President of the CLC and one representative of each of the faculties concerned with recommending the respective candidates. The President of the CLC shall serve as chairman of this committee, and correspondence shall be directed to him.

Congregations and boards are urged to use the services of the committee on graduates in exercising their right to call graduates into the ministry, in order that the needs of all may be best considered and supplied. To facilitate this work, congregation and boards are requested to make their needs known to the committee at an early date. The function of the committee is to recommend to the calling congregation or board the best qualified graduate or graduates. When the committee has forwarded to the calling congregation or board its recommendation, that congregation or board may then extend the call.

ACTION BY THE CONVENTION: TABLED

In the matter of the placement of graduates we recommend the following:

- a. That the floor committee report concerning this matter again be considered by the convention;
- b. That this report be referred to the standing committee on constitution for further study and recommendation;
- c. That the delegate conferences and individual members of the CLC be urged to submit to the standing committee on constitution any suggestions and recommendations concerning procedure of placing of graduates; and
- d. That the Coordinating Council establish temporary procedure to be followed by the congregations and boards of the CLC in the placement of graduates.

ACTION BY THE CONVENTION: ADOPTED

Note: The following is the action taken on the Constitution by the Convention:

ARTICLE III: CONFESSION

The doctrinal position of this body is defined by the following statements:

- A. We accept without reservation the canonical Scriptures of the Old and the New Testaments as the verbally inspired Word of God (verbally- 1 Corinthians 2:13; inspired - 2 Timothy 3:16; see also 2 Peter 1:21) and therefore as the sole and only infallible rule of doctrine and life.
- B. We confess the Apostolic, Nicene, and Athanasian Creeds and the Particular Symbols of the Lutheran Church as published in the Book of Concord of 1580, because they are a true exposition of the Word of God.

This we believe, and beside this no contrary doctrine is to be taught.

- C. We also subscribe to the Brief Statement of 1932.
- D. Because of differences that have arisen within the Synodical Conference we have found it necessary to define our position in a particular statement entitled Concerning Church Fellowship as well as in Theses on the Relation of Synod and Local Congregation to the Holy Christian Church and Theses on the Ministry of the Keys and the Public Ministry.

NOTE: The changed order of this Article, as here printed, was recommended to the standing constitution committee.

ARTICLE IV: MEMBERSHIP

B. Voting Membership

- 1. Application for voting membership shall be made in writing accompanied by a statement of subscription to this constitution. Congregations making application for voting membership shall also submit their constitutions for review and approval.
- 2. Voting privileges at convention shall be granted to one accredited delegate of each congregation holding voting membership and to pastors and male teachers who are serving member congregations and schools.

Note: Action on point # 2 was deferred until a committee, appointed by the president, shall have studied and submitted the findings to the Standing Committee relative to the following questions:

- a. Shall any or all professors have voting privileges?
- b. Shall pastors, professors, and teachers emeriti have voting privileges?
- c. Shall pastors, professors, and teachers, who are temporarily without a call, have voting privileges?
- d. Shall any or all of the foregoing have advisory capacity?
- e. Shall the Standing Committee's proposal that the larger congregations be granted an additional delegate be accepted?

The Standing Committee is to submit its proposal to the next convention.

3. No cumulative or proxy voting shall be permitted.

ARTICLE V: OFFICERS

Officers of this body shall be:

- A. A president
- B. A vice-president
- C. A secretary
- D. A moderator
- E. Conference visitor

A. President

5. The president shall be available for counseling when called upon by members of the organization, i. e. pastors, professors, teachers, and congregations. The president is assisted in this work by the conference visitor to whom these particular duties have been entrusted on a conference level. Individuals and groups within congregations are to seek counsel from their respective pastors, but may appeal to the president in disciplinary cases as outlined in Article VIII, Section B.

E. Conference visitor

The conference visitor shall be a pastor elected by his respective delegate conference for a period of two years, subject to the approval of the subsequent convention.

The duties of the conference visitor shall be:

1. He shall represent the president at his request, particularly with respect to the duties of the president referred to in Article V, A, Paragraphs 2 and 5.
2. He shall make his services available to pastors and teachers of the Word who desire to seek his counsel and encouragement in the discharge of their official duties and the problems of their personal life.
3. He shall give attention to exhortation and the need of correction where instances of pastoral laxity or of doctrinal or moral aberr-

rations on the part of the clergy come to his attention in a manner orderly and consonant with provisions of Holy Scripture (Mt 18:15).

4. In the discharge of his responsibilities he shall counsel with the president in matters affecting the common welfare of the body and shall be held to refer any disciplinary needs within his jurisdiction to the office entrusted with such affairs under Section B of Article VIII.

ARTICLE VI: BOARDS AND COMMITTEES

4. Board of Trustees

The board of trustees shall be elected by the body as its legal representative and have sole authority to execute all legal documents and make disbursements according to the directives of the convention.

Requests for extra-budgetary or deficiency appropriations shall be directed to the president, who shall have authority to allow these requests after consultation with the chairman of the board of trustees or with the coordinating council, if this is possible.

NOTE: The words underlined have been referred to the Standing Committee.

The board of trustees shall appoint a treasurer who need not be a member of said board and who shall not hold any other elective office in the body during his tenure of office. This treasurer shall be known as the treasurer of the corporate body; he shall receive and disburse all funds according to instructions and give an annual report to the convention.

General Duties of the Boards

The various boards shall keep themselves informed on the status of the treasury and conduct their work within the adopted budget. In the event the monies are not available the Board of Trustees may borrow the money needed for the adopted budget.

NOTE: Paragraphs two and three of this section remain unchanged.

ARTICLE VII: CONVENTIONS

3. Each member congregation shall be entitled to one delegate. All accredited delegates, male teachers, professors, and pastors shall be entitled to vote.

NOTE: This point remains tabled.

ARTICLE VIII: SUPERVISION AND DISCIPLINE

A. Supervision

2. The office of the President shall be specifically charged with the supervision of the public teaching and preaching of the Word within the membership of this body. In its behalf the President shall take all proper measures to insure the maintenance of the public doctrine and practice of this body in conformity with its official confessions.
4. The second paragraph of this point was deleted.

ARTICLE IX: AMENDMENTS

- A. This section was deleted.
- B. Proposals to alter or repeal any alterable or repealable article of this Constitution shall be offered to the president in writing and presented to the membership at least three months preceding any action thereon. A two-thirds majority of the votes cast shall be necessary to pass the alteration or repeal. The convention may edit properly submitted amendments provided the intent of the amendment is not altered.

NOTE: Point B was referred to the Standing Committee for rewording. The words underlined were added by the convention.

BY-LAWS

1. Board of Doctrine

The Board of Doctrine shall be composed of four members, to be appointed by a committee consisting of the President, the Vice-President, and the Conference visitors. These appointments shall be made at each convention of the CLC and ratified by that convention.

4. Board of Trustees

A. Composition

The board of trustees shall be made up in the ratio of three pastors and three laymen. The members of the board of trustees shall not be members of any other board. The term of individual members shall be six years. The board shall be elected in such a manner that the term of one-third of its membership expires every two years.

6. Call Committee

The committee for calling professors at synodical educational institutions shall be composed of the Regents together with one representative from each board, elected by said board from its midst. This representative shall not be a professor. The president and secretary of the Board of Regents shall be the chairman and secretary respectively of the Call Committee.

Note: The second paragraph remains unchanged.

7. Budget Committee

The body shall have a Budget Committee which shall consist of the executive committee of the Board of Regents, Board of Missions, and the Board of Trustees. This committee shall propose the annual budget which shall be presented to the convention for action. The chairman of the Board of Trustees shall be chairman of the Budget Committee.

10. Definition of Ex-officio Member

The term ex-officio member shall mean that the person so designated has all privileges of membership, including voting. His attendance and participation at meetings, however, shall not be required.

11. Statistician

The statistician shall be appointed by the president. He shall make a statistical survey of the body and report at each convention.

12. Archivist

The archivist shall be appointed by the president. He shall collect and preserve the documents which in his judgment are of doctrinal and historical significance, and keep a brief chronological record of events of historical interest.

13. Coordinating Council

The coordinating council shall consist of the executive committee of the Board of Regents, the Board of Trustees, and the Board of Missions. It shall also include: 1) the editor of the SPOKESMAN, 2) the editor of the JOURNAL, 3) the president of ILC, 4) the moderator, 5) the vice-president, 6) a representative of the Board of Education, 7) a representative of the Board of Doctrine, 8) the chairman of the committee of control of the CLC Book House, 9) the visitor of any conference not already represented on the council, 10) the president of the CLC, who shall call and preside at meetings of the coordinating council.

The primary function of the coordinating council shall be to coordinate the work of the various boards of the body.

IX. FINANCES

A. Report of the Board of Trustees

Dear Brethren:

Your Board of Trustees was elected at Sleepy Eye in January 1961 and during the following months arrangements were made for an orderly transfer of funds from the so-called Stambaugh treasury and the treasury of the Interim Conference to go into effect July 1, 1961. A careful study was made of previous, current, and anticipated receipts and disbursements in the above-mentioned departments, on the basis of which a budget was prepared in the Coordinating Council a year ago and subsequently adopted with a few additions at the convention in Spokane in August 1961. At the beginning of the first fiscal year, July 1, 1961, the balance of funds in the Stambaugh and Interim Conference treasuries were transferred to the treasurer of the CLC, Mr. Orville Noeldner, South Shore, South Dakota. A few minor corrections had to be made after July 1, 1961.

The treasurer will submit a detailed up-to-date report. We are, however, happy to report that receipts and disbursements since July 1, 1961, have been just about equal so that all requisitions could be paid promptly at all times. Indications are that all departments will remain within the budgeted allotments and that the first fiscal year will close with a balance about equal to that with which the fiscal year began. For these blessings we thank our gracious Lord. However, we need to remind ourselves that the budget requests at Spokane were "cut to the bone" and that the hoped-for expansion, especially in our missions, was not realized.

As of April 1, 1962, there were \$2,514.96 in the Church Extension Fund. Regulations are being drawn up. No requests for loans have been submitted.

The furlough fund needs special consideration if the monies are to be at hand when needed. April 1, 1961 — \$366.37.

X. MISCELLANEOUS MATTERS

A. Memorial Re. Committee on Religious Liberty

The Church of the Lutheran Confession
In Convention Assembled
August 9-14, 1962
Manchester, Wisconsin

Brethren:

The present political-religious furor caused by the recent United States Supreme Court decision, ruling unconstitutional the joint recitation of a state-written, state-sanctioned prayer in the public schools of New York State, has again brought to the surface the disturbing fact that there are those who would destroy our religious liberty (as we understand the term).

These attacks upon our religious liberty, in recent years, have taken the form of baccalaureate services in public schools, the reading of the Bible for its spiritual value in public schools, Christmas programs in public schools, Federal Aid to religious schools, and now even plans for a Constitutional Amendment to permit joint prayers in public schools.

In general, these attacks on religious liberty have found acceptance with the majority of the American people. The overwhelming derision which greeted the Supreme Court decision on prayer in the New York public schools is evidence of that. The motives of attack are various, but the voices in support of that decision are few. Were our voices among those few in support?

Since this legal decision tends toward our particular religious beliefs concerning the separation of Church and State, and eventually it may aid our children against forced religious unionism in the public schools, were we of the CLC in the forefront of public support for the Supreme Court decision? Did the members of our clergy, and our lay-people, write letters to our representatives, giving moral support to this decision, and condemning the serious attempts to write a Constitutional amendment which would permit joint prayers in public schools?

I suggest that our voices should have been, and should be, heard! Should not Christians, as citizens, take an active interest in the affairs of the Government? Perhaps they need some urging! In these troubled times, when our precious religious liberty is under constant attack, would it not be well if our Christians of the CLC were kept informed of what is continuing to happen on the political-religious scene? And urged to use their citizenship toward making their voices heard in the Halls of Congress on legislation affecting the political-religious community. Perhaps they need some guidance!

To meet these objectives, I respectfully suggest to the 1962 Manchester Convention of the CLC the formation of a regular standing committee, a "watch-dog committee," on the political-religious scene.

To outline in brief what I have in mind, may I offer the following formal wording:

- WHEREAS the God-given boon of religious liberty, which in this country is still ours to enjoy, is a blessing from our God which we should not lightly take for granted; and
- WHEREAS this blessing of religious liberty has been, continues to be, and surely shall be, under constant attack from various sources and by sundry forces; and
- WHEREAS it will weigh upon those who want to continue to enjoy this unique type of religious freedom to fight for it by every legal means at hands; and
- WHEREAS Christians surely cannot leave it up to the heathen and to the indifferent to protect their religious liberty in any nation; and
- WHEREAS Scripture does not forbid the participation on the part of God's children in the affairs of the State, but rather implies such participation, for the good of mankind, in passages such as "Ye are the salt of the earth," and "Render therefore unto Caesar the things which are Caesar's"; and
- WHEREAS such participation in the affairs of the State by our individual Christians will presuppose this knowledge of the problems at hand; be it therefore
- RESOLVED that the CLC authorize the formation of a Standing Committee on Religious Liberty, and be it further
- RESOLVED that the composition of this Standing Committee be determined by the officers of the CLC; and be it also
- RESOLVED that the duties of this Standing Committee on Religious Liberty be outlined as follows:
- A) To be a "Watchdog Committee" over the religious rights of our members under the U.S. Constitution, pointing out to the members of the CLC possible infringements on, and potential dangers to, that religious liberty.
 - B) To be aware of, and conversant with, affairs on the National and State political-religious scene, which are affecting, are of interest to, and should be known by, the members of the CLC.
 - C) To bring these important matters to the attention of the members of the CLC by way of our official Church papers, and otherwise, with interpretation, explanation, and analysis.
 - D) To encourage our individual members to exercise their rights and duties as citizens to make known to their representatives their position in regard to legislation and other developments on the political-religious scene.

II. PRESIDENT'S REPORT

To the Special Convention of the Church of the Lutheran Confession, assembled at Eau Claire, Wisconsin, January 9-10, 1963.

Dear Brethren:

As we stand on the threshold of this new year, it at once becomes delightfully clear that the Lord has much work laid out for us. At first sight it may seem like more than we are able to do. We are almost overwhelmed when we look at the tasks which the Lord has placed squarely before us in our missions and in connection with Immanuel Lutheran College. But we are not dismayed; for we have His promise that He will be with us and that He, in answer to our prayers, will supply the strength for every task which He assigns. Let us therefore go forward resolutely, relying on His promises.

This special convention was called for the sole purpose of considering the reports of the Policy Committee and the Planning Committee, both of which are concerned with the vital interests of Immanuel Lutheran College, the precious educational institution which God has given us for the preparation of laborers in His vineyard.

To any one at all familiar with the conditions under which Immanuel College must do its work, it is perfectly obvious that courageous, not to say drastic, action on our part is called for if the institution is to continue to prosper. An assembly room, a library, and a gymnasium are urgently needed, and the dormitory situation is all but desperate.

The regular convention of last August was quite aware of these needs but could take no definite action until what has been called the matter of policy, i. e., whether the high school, college, and seminary departments ought to be separated, has been settled. As a temporary solution of the most urgent dormitory problem the purchase, with approval of the Coordinating Council, of an apartment building in Mankato was authorized. To date no suitable building has been found at a price which the Coordinating Council was ready to approve.

The convention created a Policy Committee which was to make a thorough study of the question of policy as defined above, and to report its findings to the next convention.

The Planning Committee was instructed to continue to function and to be ready to recommend a permanent site or sites as soon as the question of policy would be settled.

The Policy Committee has done its work. Its report has been placed into the hands of the delegates. Consideration of this report is the first order of business of this convention.

Consideration of the Planning Committee's Report is contingent upon favorable action on the report of the Policy Committee. The Planning Committee proceeded on the assumption that the convention would adopt the recommendation of the Policy Committee in substance.

While I certainly do not want to minimize the other important questions that are before us, I do believe that the big question with which you will have to wrestle is:

Will the Church of the Lutheran Confession be served best by transplanting the three departments of Immanuel Lutheran College to Eau Claire as recommended by the Planning Committee or would it be wiser to leave the institution in Mankato where it was born, and to take steps at once toward supplying the needed facilities in or near Mankato?

I trust that all the information the delegates need to enable them to answer this important question wisely will be placed before the convention.

May God be with us and help us to find and cheerfully accept His solution to our problems so that we may be able joyfully to go forward with His blessing. God grant it for Jesus' sake. Amen.

WHEREAS having our high school, college and seminary departments at one site and in the same city keeps the gifts God has given us in our teaching personnel confined to one area, and

WHEREAS having all departments in one plant and on one campus poses problems in administration and discipline, and

WHEREAS separating our high school department from our college department and seminary department and locating the college and seminary departments at a different site will serve a wider area, therefore

BE IT RESOLVED that we recommend the separation of the high school department from the college and seminary departments in different areas as an ideal to be carried out as soon as feasible, however

WHEREAS immediate separation would confront us with problems for which we have no ready solution, therefore

BE IT RESOLVED that for the present we continue to operate our high school, college and seminary at one location while at the same time separating the departments as far as possible.

IV. PLANNING

A. Planning Committee Report

WHEREAS this convention of the CLC has approved the Report of the Policy Committee, and

WHEREAS the Ingram Estate of Eau Claire, Wisconsin, has been offered to us together with all the buildings and equipment for the total sum of not more than \$85,000.00 cash or \$10,000.00 down and \$7,500.00 per year plus interest for 10 years (interest to be prime interest plus 1%), and

WHEREAS this property permits further development of the physical needs of our educational institutions, and

WHEREAS the 75 acre tract together with the buildings would serve our present needs as well as the expected expansion in the foreseeable future, and

WHEREAS the equipment and buildings will provide adequately for our immediate needs, and

WHEREAS all buildings would meet code requirements in respect to fire and safety laws, and

WHEREAS it would be wholesome to have a permanent site for our schools as soon as possible, and

WHEREAS the proposed purchase would solve the pressing housing problem of our ILC, and

WHEREAS this purchase could be accomplished without hindering or retarding our mission effort,

THEREFORE THE PLANNING COMMITTEE RECOMMENDS TO THE CLC CONVENTION THAT IT BE RESOLVED

1. that the Board of Trustees be instructed to purchase from the Minnesota Foundation the above-described property known as the Ingram Estate, together with the equipment for not more than \$85,000.00, and
2. that the Board of Trustees be authorized to borrow sufficient funds to make the down payment in accord with the agreement of the option, and
3. that the Praesidium, together with the Visitors of the Conferences make plans immediately to liquidate or at least to make a sizeable reduction of the debt incurred in connection with this purchase by a special collection in our congregations, and
4. that the Board of Trustees encourage the issuance of bonds among the constituents of the CLC to cover the balance of the debt, and
5. that the Board of Regents be authorized to sell or dispose of furniture and equipment which are not necessary or practical for our purpose, and
6. that the Board of Regents be authorized to make changes, necessary repairs, and alterations, not to exceed \$3,000.00, so that everything will be ready for the 1963-1964 school year, and
7. that the Board of Regents make provisions for the care of the property after the purchase is completed, and
8. that the Board of Regents be granted funds necessary to move the effects of ILC from Mankato, and
9. that the Board of Regents be granted additional funds to move the households of the professors, and

10. that the Board of Regents prepare a budget for the 1963-1964 school year will take into account beside the normal current expenses the additional cost of making use of other buildings on the property.

V. SUNDRY BUSINESS AND MOTIONS

1. Committee # 3: Study Committee

This committee was made up of the personnel of Committee # 2 with the addition of a member of the faculty of ILC (M. Galstad), a member of the Board of Regents of ILC (Rollin Reim), a member of the Board of Trustees (H. C. Duehlmeier), and a member of the Board of Missions (H. E. Rutz). The committee evaluated the relative needs, costs, and other factors of either maintaining the ILC campus at Mankato or removing it to Eau Claire. The convention discussed this report at length, but took no action. The discussion provided the background for the action taken on the Planning Committee Report.

2. Division of Departments at ILC: By a vote of 40 to 17 a motion prevailed NOT to divide the departments of the school.
3. \$100,000.00 Capital Investment Drive: A motion unanimously prevailed to make such a drive and to complete it by the August Convention.
4. Disposal of Property at Mankato: A motion prevailed that the Board of Trustees work out a property settlement with Immanuel Lutheran Church. An amendment followed authorizing the Board of Trustees to sell or convey the ILC property at Mankato for the consideration of \$1.00 and other valuable considerations.
5. Authorization to Purchase: By motion the Board of Trustees was authorized to execute the purchase contract and to obtain the necessary funds.
6. Ways and Means Committee: By motion the Moderator was instructed to appoint a Ways and Means Committee of two to implement the \$100,000.00 drive. Pastors Ralph Schaller and M. J. Witt were appointed. Funds were authorized for the committee.
7. Motion of Thanks: By motion Messiah Lutheran Church was thanked for hosting the convention.
8. Press Committee: The Moderator appointed President Albrecht and Pastor A. Gullerud to the Press Committee.
9. Authorization to Build: A motion prevailed that the Board of Regents and the Board of Trustees be authorized to carry out the resolution to build an adequate classroom addition.
