

I. Membership of Pastors

WHEREAS Max M. Groeschel has been certified through colloquy by our Board of Doctrine as being in complete doctrinal agreement with the Church of the Lutheran Confession and has been called into the public ministry, and

WHEREAS he has applied for membership in the Church of the Lutheran Confession, THEREFORE we recommend that he be received into voting membership.

WHEREAS Michael A. Sydow was presented to the church as a candidate for the pastoral ministry by our seminary and has been called into the public ministry by Holy Cross Congregation of Phoenix, Arizona, and

WHEREAS he has applied for membership in the Church of the Lutheran Confession, THEREFORE we recommend that he be received into voting membership.

II. Membership of Congregations

WHEREAS the congregation of Immanuel Lutheran Church of Winter Haven, Florida has applied for membership in the Church of the Lutheran Confession, and

WHEREAS the congregation has declared its agreement with the confessional position of the Church of the Lutheran Confession, and

WHEREAS the constitution and by-laws of the congregation have been reviewed and assurance has been given that suggested changes will be made,

THEREFORE we recommend that this congregation be received into membership of this body.

WHEREAS Redeemer Evangelical Lutheran Church of Dowagiac, Michigan has applied for membership in the Church of the Lutheran Confession, and

WHEREAS it has expressed full agreement with our doctrinal position, and

WHEREAS its constitution and by-laws have been reviewed and assurance has been given that suggested changes will be made,

THEREFORE we recommend that this congregation be received into the membership of this body.

III. Legally Dissolved Incorporations

WHEREAS some of our congregations were incorporated for a stipulated period of time (50, 75, and 100 years) and not in perpetuity,

THEREFORE we urge our congregations to make certain that they are still corporate bodies according to law.

IV. Need for a Model Constitution

WHEREAS, our Lord asks us to do all things "decently and in order," and

WHEREAS, this applies also to congregational constitutions, and

WHEREAS, our constitutions are also legal documents,

THEREFORE we urge utmost care in striving for clarity of expression and precision of language.

WHEREAS there is obviously a need for a model constitution for congregations,

THEREFORE be it resolved that the standing constitution committee draw up such a model constitution before the next regular convention.

V. Roster of Pastors, Professors, and Teachers

WHEREAS there has been some lack of policy in drawing up our roster of pastors, professors, and teachers,

THEREFORE be it resolved that our coordinating council prepare a statement of policy regarding pastors, professors, and teachers to be included in our official directory.

VI. Attendance

The committee reports 108 voters (48 lay delegates, 47 pastors, 6 teachers, and 7 professors) seated at the convention; 32 were excused and 9 were unexcused.

We acknowledge the interest of our affiliated congregations in that some had delegates present at this convention, while other favored us with sending excuses.

VII. Credential Procedure

We bring to your attention the resolution passed last year but not carried out, to wit: "In order that the committee may give an accurate account of convention attendance, we recommend that excuse forms be made available at the secretary's desk."

We strongly urge that all excuses be in written form.

In Christ, our Blessed Savior, Friends and Workers in His Vineyard:

Go ye into all the world and preach the gospel. Mark 16:15. This is our Savior's one great commission to His church. To all who trust in Him as their Savior, who has redeemed them with His own blood, He says: Go ye and preach the gospel. To you and me and all who love Him, He says: Go ye and preach the gospel.

To carry out this great commission is the real purpose for which we have banded together under the name of Church of the Lutheran Confession. Everything that we say and do as a church must be in the interest of the gospel. Anything that is not in the interest of the gospel is none of our concern. We are not to fritter away our time and strength and resources in an effort to make this world a better place in which to live, or to help our beloved country solve its economic and social and political problems. We are not to ferret out false doctrine in other church bodies or to deplore and denounce what is wrong in them although we must at times warn against error lest those whom the Lord has committed to our care be deceived and misled. We are to preach the gospel of Christ which is the power of God unto salvation. We are to say to a sin-sick world: Behold thy God, thy God who has fearfully and wonderfully made thee, thy Savior who has redeemed thee, who has atoned for all thy sins, who died for thee and rose again and now lives and governs all things in heaven and on earth for the good of His elect who are to inherit the kingdom.

In the field of higher education may our purpose never be to train doctors and lawyers, scientists and diplomats, but to set the hearts of our students aflame with the love of Christ which passes all understanding and so to make them able and consecrated servants of the Word, humble servants of the Lord Jesus eager to preach the gospel.

In the field of missions, may we never try to build with any other means than the blessed gospel, the eternal Truth that we are redeemed, not with corruptible things such as silver and gold but with the precious blood of Christ as of a lamb without blemish and without spot.

We acknowledge with deepest gratitude that in the past year also the gospel was preached and taught in our churches and schools in season and out of season. We know that it has borne precious fruit because the gospel is power and life and never returns void but accomplishes that which the Lord pleases and prospers in the thing whereunto He sent it. We thank God with humble hearts that in spite of our unworthiness He is still willing to use us to proclaim His saving gospel so that sinners may be brought to repentance, may live as children of God and finally enter His glorious, eternal, heavenly kingdom.

May everything that we say and do at this convention be in the interest of the gospel and serve the glorious purpose of proclaiming the glad tidings of Him who laid down His life for the sins of the whole world and who would have all men to be saved.

As we plan and organize our work for the coming year, let us not instruct our boards to undertake anything that we are not prepared to support wholeheartedly with our gifts and our prayers. However, let us cheerfully and courageously undertake all that our Lord asks of us; for with His help we can do all that He asks if we apply ourselves in the strength which He gives.

Our sincere hope of reaching complete agreement with the Wisconsin Ev. Lutheran Synod in the matters that lie between us, as defined by the Spokane convention in 1961 and elaborated on in a Spokesman article in 1962, has not been realized. There have been no discussions with representatives of the Wisconsin Ev. Lutheran Synod since January, 1964.

When the Aug. 9, 1964 issue of the Northwestern Lutheran brought a district resolution charging the Church of the Lutheran Confession with having by its actions "blasphemed the gospel" (corrected in the Oct. 18, 1964 issue to read "the actions of the Church of the Lutheran Confession have caused outsiders to blaspheme the gospel"), and expressing the conviction that "negotiations toward recognition should not be begun or continued under these conditions," it appeared that discussions of the issues that lie between Wisconsin and the Church of the Lutheran Confession would have to come to a halt. The Wisconsin Synod would surely not want to discuss doctrine with people it considered guilty of blaspheming the gospel. Nor would we be able to discuss doctrine with people who charged us with blaspheming the gospel.

Correspondence with President Naumann brought out that the Wisconsin Synod does not desire to be understood as making or upholding the above charge when it published it in its official organ.

Under date of April 6, 1965 the following communication was received:

Dear Members of the Church of the Lutheran Confession:

At the time of the last meeting of your Board of Doctrine and the sub-committee of our Commission on Doctrinal Matters (South St. Paul, January 2-3, 1964) your Board of Doctrine expressed the conviction that a careful review of our Synod's official documents and actions between 1955-1961 would be necessary in order to demonstrate where a difference with respect to the principles of church fellowship between our two bodies lies. (Cf. Review of Meetings Held Thursday, January 2 (C.L.C.) and President Albrecht's Report to the Convention of the CLC, 1964).

In the interest of correctly understanding the answer we are submitting to your recommended procedure, we consider a review of the background and history of our discussions with you to be imperative.

Following upon our suspension resolutions of 1961, your president wrote an article for the January, 1962, issue of The Lutheran Spokesman in which he evaluated these resolutions. (What Separates the CLC from Wisconsin?) In his letter to President Naumann (Feb. 9, 1962), your president referred us to his article and asked that it be regarded as your official evaluation of our 1961 suspension resolutions. In this article President Albrecht stated:

There is nothing in Wisconsin's recent suspension resolution that would show that Wisconsin has receded from the unscriptural position to which she has clung and which she has stoutly defended. The supporting "whereas's" (1, 2, 4, 5 and 11) indicate that Wisconsin still holds and defends the above error. (p. 10)

Since in an exchange of correspondence President Naumann had called attention to the intent and significance of our 1961 suspension resolutions, President Albrecht stated further in his Feb. 9, 1962, letter:

If we have not grasped the true intent of your resolutions, please be assured that we would be most happy to be so advised.

On March 16, 1962, in a letter to your president, President Naumann reported as follows on our Commission's action relative to President Albrecht's Spokesman article:

Our Commission on Doctrinal Matters considered your article in the January issue of the Spokesman at its recent meeting. At this meeting it was resolved to ask me to convey to you the Commission's conviction that you do not fully grasp the true intent of our resolutions, and that our position is consequently not accurately reflected in your article.

In this same letter President Naumann also voiced the Commission's opinion, namely that rather than

attempt to reach an understanding by correspondence...our Commission stands ready to meet with representatives of your Church of the Lutheran Confession, very likely your Board of Doctrine, to discuss this entire matter with you.

President Albrecht's reply of April 12, 1962, reiterates his desire to hear our interpretation of the 1961 suspension resolution. He further suggested:

...that it is desirable that you state in advance of the meeting just where you feel we did not grasp the true intent of the Wisconsin suspension resolutions. If the resolutions in themselves do not reflect the true spirit of your convention, or if we, not having been there to hear the discussion, have failed to grasp it, we would be most happy to have your official interpretation.

After careful deliberation, our Commission on Doctrinal Matters resolved that a sub-committee of our Commission meet with your Board of Doctrine. No document was prepared for this discussion, since, as President Naumann stated in his letter of October 11, 1962, our Commission "from the outset did not envision an exchange of correspondence nor written presentations." The intentions of the Commission were, and so it instructed its sub-committee, in a meeting with your Board of Doctrine to "interpret our Synod's 1961 resolutions" to you. (Minutes of Commission, August 15, 1962)

We are stating and stressing the nature of the assignment given to our sub-committee because a review of the correspondence seems to indicate somewhat of a misunderstanding as to the scope of this assignment.

Two meetings were arranged and held between your Board of Doctrine and the sub-committee of our Commission, the first at Mankato on November 10, 1962, the second at South St. Paul on January 2-3, 1964.

In these meetings our representatives, according to their report, attempted to adhere strictly to their assignment. In doing this, it became clear to them that you ascribed to us a position on church fellowship (cf. Prof. E. Reim's article on Rom. 16:17.18, Journal of Theology, Dec. 1962, p. 1-11) which we disavow. For that reason you were asked, on the basis of our Commission's statement on the principles of church fellowship and Prof. Carl Lawrenz's exposition thereof, to show where our position deviates from the Scriptures. This required, as you correctly perceived, that you "define and substantiate the charges" relative to our principles of church fellowship made against our Synod. (Cf. CLC Review) It was in this connection that your Review speaks of a "seeming inability to reduce the Wisconsin position on termination of church fellowship to a clearly expressed statement of principle." Consequently you stated it as your conviction that the historical review to which reference has been made would be necessary.

In its meeting of May 18, 19, 1964, our Commission gave careful attention to your recommendation. It resolved and later reported to the districts of the Synod:

The Commission is of the conviction that a joint review of all that happened between 1955-1961 would not serve a wholesome purpose.
(Report to the Nine Districts, May, 1964)

This, of course, was not intended to mean that the official pronouncements of a church body and its history can be ignored when evaluating its confessional position. However, our Commission had in mind that your evaluation of our Synod's resolutions, actions, and official interpretations during this period (1955-1961) became the basis for the very issues which led to the separation between many of the present members of the CLC and our Synod - and that a restudy or reexamination of these years would seem to hold little promise of a more fruitful discussion at this time.

Nevertheless, we in no way wish to repudiate what we also reported to our districts in May, 1964, namely:

It is, however, our hope that another approach may still be found that would prove to be fruitful.

As such a possible approach, we had, for example, thought of a discussion in which the current position and practice of both bodies might be evaluated in order to determine whether the principles of church fellowship which our two bodies presently hold are in agreement.

Such an approach, involving a doctrinal discussion of a more general nature, if it is to be fruitful, would, in our opinion, require an atmosphere conducive to such a discussion. Before our Commission would commit itself to enter upon such a discussion, it would respectfully request the following assurances from your Board of Doctrine:

1. that your body acknowledges that in entering upon such discussions it is dealing with representatives of a church body which was and is willing to submit to the authority of the Word of God;
2. that your Board also understands that the need for an objective discussion of the basic principles in question renders premature any discussion of grievances, inasmuch as that might becloud the issues;
3. that it is agreed that in all instances individual cases must be handled by those in whose jurisdiction their evaluation and adjudication properly belong;
4. that during the course of such discussions the participants publish only such reports of these discussions as have been approved as factual by both parties.

We hope and pray that this carefully drawn report and all subsequent action will serve the greater glory of God and the welfare of His Church.

Under date of April 30, 1965 I sent the following reply:

Dear President Naumann,

Acknowledgment is herewith made of receipt of your communication of April 6th, containing an invitation of your Commission on Doctrinal Matters to resume discussions of the issues that still lie between us.

The invitation and proposals of your Commission were carefully considered by our Board of Doctrine as well as our General Pastoral Conference which convened here at Bowdle last week.

We are happy to note that your Commission by issuing the invitation implies 13 that it does not share the view of the Dakota-Montana District convention that actions of the Church of the Lutheran Confession have "caused outsiders to blaspheme the gospel" and that "negotiations toward recognition should not be begun or continued under the circumstances."

We concur in your suggestion that deliberations are to center on the current doctrine of church fellowship and related church practice of both bodies with the understanding that this does "not...mean that the official pronouncements of a church body and its history can be ignored when evaluating its confessional position." (It is our belief that the doctrinal position of a church body can be correctly understood only when viewed in the light of its history, its formal resolutions and official statements.)

In regard to the four areas in which assurances are requested of us as a prerequisite for resumption of discussions the following points are offered as a proposal:

- A. That we recognize the need for prior mutual agreement on procedure and will be glad to conform to any scriptural ground rules which will protect and further the purpose which both you and we seek.
- B. That by agreeing to engage in doctrinal discussions with representatives of your church body we have already indicated that we accept your profession of willingness "to submit to the authority of the Word of God." To proceed with such discussions on any other basis would be both unscriptural and fruitless. At the same time we do not consider it to be within our province to read or judge the hearts of the members of your church body. Only their words and actions are subject to our scrutiny in the light of the Word.
- C. That in any other matters of concern raised by your proposed stipulations we desire to be accorded the same trust which prompts us to refrain from introducing any reservations on our part. We urge that each party to the discussions credit the other with a sense of Christian propriety that refrains from intruding upon the jurisdiction of others and knows that our God is a God of order and not of confusion.

Praying that God may by His Holy Spirit guide and direct the hearts and minds of all of us so that His will may be done and His name may be glorified, I am,

The undersigned is chairman of the Committee on Lutheran Union of the Concordia Lutheran Conference. As such I have been instructed by our church body to send you the following information.

In June of this year our Conference met at Lebanon, Oregon, for its annual convention. Union matters, of course, formed a major portion of our discussions and deliberations.

Among the Union resolutions passed by our delegates was the following:

"Resolved, that the Committee on Lutheran Union inform the President of the Church of the Lutheran Confession that we are still in the process of studying their confessional statements of Church and Ministry and Church Fellowship, and that we are still interested in meeting with them with a view toward establishing a God-pleasing fellowship based on full agreement in God's Word."

I am happy to send you a copy of this resolution so that you and your brethren might know the situation between our respective groups as of this date.

May the Lord of the Church grant His blessing to our study of your confessional statements and to any meetings with one another which may materialize in the future!

Article in Journal of Theology

At our convention at Fond du Lac a year ago one of the brethren felt constrained to express grave doubt and misgivings concerning the doctrinal content of an article that appeared in the Journal of Theology. Pastor Otto J. Eckert assures me and desires to assure you all that as a result of his continued careful study of this

article, also in the original, these doubts and misgivings have vanished completely, particularly since the article was not intended by the author nor presented in the Journal as a precise and definitive statement of doctrine, and is not considered as such by us.

The premises for this statement on the part of Pastor Eckert are still under discussion.

As for the publication of this or similar articles in our Journal of Theology, it should be understood that editorial responsibility is always accepted for the doctrinal content; that this doctrinal content is not impaired by an occasional exegesis with which not everyone may agree, provided that such exegesis does not contradict other clear passages of Scripture.

Withdrawals

Pastor J. B. Erhart of St. Louis, Mo. has accepted a call into a synod not in fellowship with us and has thereby forfeited his membership in the CLC. He has not defined his reason for this action but stated that he is not aware of any divisive issue, doctrinal or otherwise, between himself and the synod in which he has applied for membership.

Pastor Wm. Wiedenmeyer of Phoenix, Arizona has declared his withdrawal from the CLC because he does "not share the conviction of the CLC as expressed by resolution at the Spokane convention in 1961: That the Wisconsin Synod has deviated from the doctrine of the clarity of Scripture; deviated from the Scriptural doctrine of Church Fellowship; and instances of violating the sanctity of the Call."

Pastor Otto Abrams resigned as pastor of Grace of Fridley, Minnesota for reasons of health. When he subsequently established fellowship relations with a synod not in fellowship with us he forfeited his membership in the CLC.

Unprinted Memorials

Several memorials were received too late to be included in the Prospectus. These are submitted to the convention at this time:

- 1) From the Wisconsin Delegate Conference, re special conventions in 1967 and 1969.
- 2) From the Wisconsin Delegate Conference, re mission policy.
- 3) From St. John's's Ev. Lutheran Church of Okabena, Minn., re establishment of a Youth Board.

Authorization of New Construction

When it became imperative to install mechanical ventilation in the Northwest Building at a cost of approximately \$5,000.00 in order to obtain the permission of the State Industrial Commission to use the present class rooms another year (such permission could be granted for only one year), or to make a modest beginning toward a permanent solution of our classroom problem, it seemed the part of wisdom to choose the latter course. The Planning Committee did its work with this in mind and submitted its proposal to the president. The proposal was then submitted to the Coordinating Council and the entire constituency of the CLC for its advice.

After the proposal as well as a suggested method of financing had been carefully studied by the Coordinating Council and received the all but unanimous endorsement of the constituency, construction of the now nearly completed three classroom unit which meets every requirement of the State Industrial Commission was authorized. Formal approval by this convention is sought at this time.

Prof. E. Reim has been asked to present a few observations of particular concern to us on this occasion.

May God in His mercy grant us a joyful and blessed convention.

REPORT OF COMMITTEE # 2: PRESIDENT'S REPORT

I. The Preaching of the Gospel

We find ourselves in wholehearted agreement with the president that the preaching of the Gospel of Jesus Christ must be our only concern in all of our endeavors as a church body. Surely any overemphasis on other matters that diverts our attention from this chief work is detrimental to our Gospel ministry. We pray with one mind and heart that our Lord would so fill us with appreciation of this Gospel that all of our work at this convention and in the years to come will exalt our God and His marvelous grace to us poor sinners.

II. Withdrawals

Taking note of the withdrawals of Pastors Daniel Hanel, J. B. Erhart and Wm. Wiedenmeyer, we have no alternative but to consider their manner of leaving us as unbrotherly.

III. The Authorization of New Construction

We recognize the value of what has been achieved through the new construction authorized by the president, and we express our gratitude for the cooperation so freely given by the many volunteer laborers. In view of the urgency of the classroom problem, we recommend that the authorization of the new construction be approved. We are aware that some of our members were disturbed by the procedure that was followed in this case, and therefore we request referral of By-law 6 to the standing constitution committee for interpretation.

IV. Appointments

We recommend ratification of the appointments made by the president.

V. The Fifth Anniversary of the CLC

We express approval of the arrangements made by the president to ask Professor Reim to speak to us on the occasion of our fifth anniversary as a church body, and we call upon all our members to search their hearts for signs of spiritual decay, possible loss of first love, and lack of gratitude for the rich blessings showered upon us in the last five years. May the old adam in us be drowned by sincere contrition and repentance and may we rise up through the Gospel to new life and new zeal! God grant it. Amen.

Dear Brethren:

Because the work of the Board of Doctrine is properly judged only when the nature of the Board's assignment is understood, it seems well that for your convenience the constitutional provisions governing the duties of the Board of Doctrine be restated here. We quote from the Bylaws of the Church of the Lutheran Confession, Constitution, Edition of 1964, page 10:

"1. Board of Doctrine. . . .

. . . B. Duties

- a. The board of doctrine shall assist in formulating the doctrinal propositions of the Church of the Lutheran Confession.
- b. It shall have doctrinal supervision of our publications not subject to the supervision of others.
- c. It shall conduct colloquies at the request of the president.
- d. It shall, at the request of the president, represent the Church of the Lutheran Confession in doctrinal discussions with other church groups."

During the past year the board has completed the process of the colloquy of Mr. Max Groeschel, and rejoices in the happy result that has already been made known to our membership.

The major activity of the board continued to center in duties imposed by the concern for our relation with the Wisconsin Synod. From time to time we have used the pages of the Spokesman and the Journal of Theology in order to report developments in these matters as they occurred. The most recent of such reports appeared in the April issue of the Spokesman. We trust that pastors, teachers and congregations have individually and jointly studied such reports so that we will be understood if in this summary we review only the most important details.

No further meetings with representatives of the Wisconsin Synod were held during the past year. We had awaited a reply to our request of January 1964 for a discussion with the entire Commission on Doctrinal Matters of the Wisconsin Synod. No such reply was received until the end of October 1964. But in the meantime the Wisconsin Commission had informed the Districts of its synod of our request and expressed the conviction that a discussion on the terms we had proposed "would not serve a wholesome purpose." They added "the hope that another approach may still be found that would prove to be fruitful."

In the Spokesman issue of February 1964 we pointed out that at the January 1964 meeting the Wisconsin representatives had stated their agreement with our principle of termination of church fellowship as outlined in an article in the Journal of Theology. The exact wording of that portion of their statement read: "With respect to Prof. Reim's article 'Admonition and Romans 16' (Journal of Theology, December 1962) we are aware of nothing in its exposition of Scriptural fellowship principles with which we would have to take exception." To this we had reference also when in the April 1965 issue of Spokesman we said that "Wisconsin's representatives . . . subscribe to our statement concerning termination of church fellowship . . ."

But such acceptance of a portion of an article in the Journal of Theology did NOT of itself establish that there is agreement in that doctrine between our church bodies. This we had at once indicated by asking for meetings with the full Commission on Doctrinal Matters in order to review Wisconsin's official pronouncements and resolutions during the years 1955-61 because many of them seem to us in disagreement with what Wisconsin's representatives now declare to be the position of their synod.

As we have said, such a review was refused; but hopes for a "new approach" were held out. Before any further proposals for discussion were received, however, another matter intervened to darken the prospects. The Northwestern Lutheran published the statement of a District of the Wisconsin Synod declaring that the Church of the Lutheran Confession had "caused outsiders to blaspheme the Gospel." The grave nature and consequence of such a slander were outlined in letters of protest to President Naumann. After some exchanges and delays a letter of February 15, 1965 informed us that the Commission of the Synod had spent more than two days in a consideration of their body's relationship with our church. In reply to our protest we were told that the Wisconsin Synod respects the findings of any of its Districts by publishing their reports but assumes no responsibility for substantiating or investigating their finds until an appeal has properly been brought to the Synod. 19.

It was possible for us to take this to mean that the Wisconsin Synod does not wish to be understood as underwriting the charge of the District which made it. Your Board read the statement of the President in that sense.

We were confirmed in our understanding by receipt of a second lengthy communication from the Commission on Doctrinal Matters, addressed to the Members of the Church of the Lutheran Confession and containing a suggestion for a new approach to the issues lying between us, specifically to that of the doctrine of fellowship. Since the District which charged us with causing blasphemy had used its accusation as the basis for a demand that the Synod engage in no discussions with the CLC, we take the proposal of the Commission as an indication to our membership that the Wisconsin Synod disclaims responsibility for the charge of blasphemy which had been laid on us.

The letter outlining the new approach has been intensively studied by the board of doctrine and discussed at the pastors' conference in April. It presents several problems. It fixes certain preconditions for a resumption of discussions. Some of its expressions seem to us ambiguous, while certain historical references are incomplete and therefore subject to misunderstanding. The letter will be presented to the convention of our church, together with all relevant correspondence. In the meantime, however, President Albrecht will represent our church in formulating and sending a reply, lest there be further undue delay in this undertaking.

The board of doctrine asks the understanding, support and prayers of all brethren as it seeks to meet its responsibilities with wisdom, firmness and faithfulness.

REPORT OF COMMITTEE # 5: BOARD OF DOCTRINE

- A. We express joy and give thanks to God that Max Groeschel, through a colloquy by our Board of Doctrine, has been accepted into our midst as a minister of the Word.
- B. 1. We are gratified to note that the Wisconsin Evangelical Lutheran Synod, through its Commission on Doctrinal Matters, has sent a letter to the members of the Church of the Lutheran Confession containing a proposal for future meetings with our body. (Cf. pages 10-12 of these PROCEEDINGS)
2. We have considered President Albrecht's letter of reply of April 30, 1965, and subscribe to its entire content as printed in these proceedings in connection with the president's report. (Cf. pages 12-13)
3. ~~To the end that discussions be held with the Wisconsin Evangelical Lutheran Synod concerning "current position and practice" in the light of pertinent past resolutions,~~ we urge our president to pursue the course outlined in his reply to the invitation of the Wisconsin Evangelical Lutheran Synod.

- C. We urge all members of the CLC to support its Board of Doctrine and to render prayers to our God that this Board may meet its responsibilities with wisdom, firmness, and faithfulness. 20
- D. We note the correspondence from Concordia Lutheran Conference and support our president's reply.

REPORT OF THE PRESIDENT OF IMMANUEL LUTHERAN COLLEGE

The school year 1964-1965 was officially opened with a special service on September 8. At this service Pastor Roland Gurgel was installed as professor in the field of Education to fill the vacancy left by Professor Galstad's acceptance of the call to Immanuel Lutheran Church in Winter Haven, Florida. The over-all enrollment showed a total of 90, divided as follows: 7 in the seminary department; 30 in the college department; 53 in the high school department. Eight of the ninety students were in attendance only part of the school year. According to present indications the seminary department will graduate ten students during the next four-year period. The prospects for pre-theological students from the other classes in high school and college after that are not too bright at the present time. It would seem that the number of students presently preparing for the teaching ministry will be insufficient to fill our needs for the years that lie ahead. It is therefore important that promising students be encouraged to prepare themselves for the teaching ministry as well as for the preaching ministry.

Our dormitories were this year practically filled to capacity. The Northwest Building, which last year housed 17 students, this year accommodated up to 26 students. At the peak we had 76 students on campus. This points up the need of providing more dormitory space and also more classroom space as our enrollment increases. This is a very present need. Also, our students who live in close and cramped quarters need to have a place to congregate in fair weather and foul; a place for their physical education classes and athletic events; a place where they may find an outlet for pent-up energy which is so abundant in youth. At present our athletic program is restricted and expensive. Gymnasium facilities are hard to find and costly to rent. An adequate assembly room for chapel purposes and other gatherings is an urgent need. The present room is by law limited to an audience of 99 persons.

The faculty has been occupied with a thorough-going study of the curriculum and as a result certain revisions are to be made which will improve and expand our present course of study. In order that education students may receive the benefit to be derived from a supervised practice teaching program, a nine-week period of practice teaching will be introduced into the course of study for education students next year. Some members of the faculty are this summer pursuing a course of study at Eau Claire State University. During the course of the summer, work has been proceeding along the line of classifying and cataloging the books of the library. We are very fortunate in having a member of our staff who has been taking courses in library science; so we can be assured that the work will be carried out according to accepted practices. The library in any college constitutes an important lifeline in education since extensive research must be carried on by students who are working on the college level. We have a long way to go before our library is brought up to what may be considered the minimum requirement. Another area in which we find ourselves deficient is in the matter of laboratory equipment. At the present time we have no facilities which make it possible for students themselves to conduct experiments in physics and in chemistry. The library and the laboratory are two weak spots in our present structure.

During the summer of 1964 the faculty conducted a seminar for pastors. Including the professors, we had a total registration of 17. The following served on the

seminar faculty: Prof. E. Reim, Prof. E. Schaller, Prof. R. Dommer, Pastor Paul 21
Nolting, and Prof. C. M. Gullerud. As a result of encouragement given, a regular
seminar program is planned for the future. It is proposed that seminars be con-
ducted in the odd-numbered years beginning with 1967 which is the 450th anniversary
of the Reformation.

We are grateful for the support and consideration that have been given the college
during the past year.

REPORT OF THE BOARD OF REGENTS OF ILC

The Board of Regents and the faculty of ILC have been busy with a study of the curri-
culum and as a result certain changes will be made to improve our present set-up.
For example, a more thorough-going and concentrated PRACTICE TEACHING PROGRAM will be
pursued in the next school year. A nine-week period of practice teaching will be
introduced into the course of study for education students.

For some time the Board of Regents has felt the need for a Dean of Students. The
need is NOW! We respectfully ask the CLC in convention assembled to create the
position of Dean of Students whose duties it shall be to be responsible for the de-
partment of all students of ILC and have direct control of discipline in general.
This position is to be filled from the faculty.

The Board of Regents together with the heads of departments of ILC have reviewed the
deanships and administrative positions. We would like to have a uniform pattern of
handling these positions. We believe that these positions ought to be temporary as
is the present situation with the presidency of ILC. It is our recommendation to
issue all future calls as calls "to the faculty of ILC," with administrative posi-
tions, exclusive of the presidency of ILC, as assignments by the Board of Regents
for a period of four years. These appointments are to be staggered. Whereas the
present term for president is a two-year term, therefore we recommend that this
term be extended to four years.

The Board of Regents has discussed accreditation of ILC and it was generally agreed
that there is a definite need for accreditation and we should move in this direction.
It is proposed that a committee be appointed by the Board of Regents to study the
principles and mechanics involved with accreditation and report to the 1966 convention.

Whereas the Board of Trustees has been given authorization by the convention to work
out ways and means for a professorage, and whereas there is a pressing need to pro-
vide adequate housing near our college, and whereas this would be in the interest of
good stewardship, therefore be it resolved that the convention authorize the Board
of Trustees to expand this project on a continuing basis.

Whereas the Industrial Commission will not permit any extended use of the present
classrooms without mechanical ventilators; and whereas the construction of the first
classroom unit would only be the beginning of the solution of our problem; and
whereas more dormitory space will be needed, therefore be it resolved that the con-
vention authorize the construction of a second classroom unit.

We suggest that the August Convention of the CLC set aside one Sunday this fall de-
signated as ILC Sunday, at which time our members will be given an opportunity to
bring a special offering to help in our classroom project.

We dare not forget the pressing need for a gymnasium for our school. In the mean-
time we recommend that an asphalt slab be laid that would be a multipurpose re-

creation area. And be it further resolved that the sum of \$1200.00 for this slab be included in the present building program.

We recommend that the wording of the 1964 Proceedings, page 28, I par. 2, Re: Use of Undesignated Money, Gifts or Bequests, be amended to read: RESOLVED that in the case of undesignated gifts or bequests in excess of \$500.00, the convention shall determine its disposition.

The Board of Regents recommends to the CLC Convention the adoption of a sliding scale for families with several children in attendance. We suggest a straight 50% of the base tuition figure for the second, third, etc., in attendance.

The sewage beds of ILC have been tested by two firms. The firm of Bohl and Proulx has given us the lowest bid which they assure us will meet all requirements with the board of health. The cost of an additional dry well and the laying of a new drainage field will be \$2636.00

The Board of Regents also wishes to apprise the convention of the need of painting Ingram Hall and the Annex.

REPORT OF COMMITTEE # 3: IMMANUEL LUTHERAN COLLEGE

- I. Assembling in convention at ILC, we are reminded once more of the exceptional blessings the Lord has given us in this school.
- II. In view of the decrease in college enrollment and the resulting shortage of workers that threatens to curtail the future endeavors of the Church of the Lutheran Confession, be it resolved that we
 - a) urge all pastors to encourage capable young people in our congregations to prepare themselves for the teaching and preaching ministries, and
 - b) adopt the recommendation of the Board of Regents that where more than one child from a family attends ILC simultaneously, the first child is to pay full tuition, and all additional children are to pay half of the regular tuition, effective in the fall of 1966.
- III. Though we agree with the printed reports regarding the eventual need for a second classroom unit and a gymnasium, we recognize that the present enrollment prospects appear to decrease the urgency of another classroom unit at this time. We deem it wise, however, that this convention authorize the construction of the second classroom unit should circumstances make this necessary. Be it therefore resolved that the Coordinating Council be authorized to proceed with erection of the second unit when and if an emergency should require it.
- IV. We note with approval that constructive changes are being made in the curriculum, including the inauguration of a concentrated practice teaching program.
- V. In order to reach a decision as to the desirability of accreditation at ILC, be it resolved that the Board of Regents be empowered to appoint a committee which shall study the principles and mechanics involved, and be it further resolved that this committee report its findings to the 1966 convention.
- VI. Whereas there is a pressing need to provide additional faculty housing near our college, and whereas this would be in the interest of good stewardship, therefore be it resolved that we authorize the responsible boards to expand this project as loans become available.
- VII. Be it resolved that the following recommendations of the Board of Regents be adopted:
 - a) That we establish a new position called Dean of Students.
 - b) That one of the members of the faculty be appointed to this position.
 - c) That all future calls be issued as calls to the faculty of ILC rather than to any certain administrative position.
 - d) That all deanships and administrative positions, exclusive of the presidency of ILC, be issued as assignments of the Board of Regents.
 - e) That these appointments be for two year periods which are to be staggered.
 - f) That we suggest that each congregation set aside one Sunday this fall as ILC Sunday, at which time our members will be given an opportunity to bring a special offering to help in our classroom project.

- g) That the wording of the 1964 Proceedings, page 28, I par. 2, Re: Use of Undesignated Money, Gifts or Bequests, be amended to read: RESOLVED that in ^{the} case of undesignated gifts or bequests in excess of \$500.00, the convention shall determine its disposition. 24
- h) That the gifts from the heirs of the Nygaard Estate to Immanuel Lutheran College in the amount of \$5,000 be designated for the first unit in the classroom building program.

REPORT OF THE BOARD OF MISSIONS

"Therefore my beloved brethren be ye steadfast, unmoveable, always abounding in the work of the Lord, for as much as we know that your labor in the Lord is not in vain." On the strength of such encouragement and promise we took up the work our Lord gave us to do. We did not accomplish what we would like to have done. Yet, in spite of weaknesses, we thank the Lord for the blessings with which He has crowned our labors.

There was no lack of opportunities to enter fields white unto harvest. The ancient Macedonian call, "Come over and help us," constantly sounded in our ears. But we had neither the men or the money to answer all of these calls. These calls will continue to request a share of the Word of Life. "Pray ye therefore, that the Lord of the Harvest would send forth laborers into His harvest."

It must be of deep concern to all of us that we have not given some of our missionaries sufficient support so that they could devote all their time and energy to the Ministry of the Word. We regret that we must ask them to be patient still longer.

We herewith present a brief picture of each mission supported wholly or in part by your mission offerings:

BEREA, ST. PAUL, MINN. This congregation is making payments on a combination chapel-parsonage. The members here have an earnest appeal for more subsidy that their pastor, Marvin Eibs, would be able to devote full time to the work of the Church. At present he must support himself through secular labor.

GETHSEMANE, SPOKANE, WASH. Here we have one example that demonstrates how richly blest the congregation that has a fulltime pastor. This mission has grown steadily since its pastor was relieved of all secular labor. They are patiently awaiting the day when they may have their own school. Robert Reim is the pastor.

GRACE, CARLSBAD, NEW MEXICO. In the interest of good stewardship in this field subsidy was almost completely eliminated. Pastor John Johannes recieved and accepted the call from Mt. Olive, Lamar, Colorado. The field will continue to be served on a limited basis.

GRACE, FRIDLEY, MINN. Here is another congregation that has built a church-parsonage combination. The parsonage lacked living space for a pastor with a family and so a number of bedrooms were finished upstairs to provide the desired sleeping quarters. Pastor Carl Thurow has accepted the call and was installed June 6th. Fridley is a growing suburb near Minneapolis. There are many fine mission opprtunities here.

IMMANUEL, WINTER HAVEN, FLORIDA. This mission has a school with three teachers. The school has proved a great blessing in providing mission prospects. They have their own House of Worship and are purchasing a parsonage. This is a most favorable area.

REDEEMER, CHEYENNE, WYOMING. Pastor Dale Redlin was installed in this congregation during the past year. He must also teach in the congregation's school. One other teacher is engaged by the congregation. Their property consists of a parsonage and church, with the school in the basement. 25

REDEMPTION, ALDERWOOD MANOR, WASH. During the past year this young mission dedicated its new parsonage. The services are held in a rented school room. This area is a growing suburb near Seattle. Norbert Reim is the pastor.

ST. PAUL, WINNER, S. D. Because of the limited mission opportunities in this area, the pastor, Karl Brandle, is engaged in part-time secular work. Subsidy was reduced by the congregation during the year. The church and parsonage here are both new.

SERVANT OF CHRIST, SEPULVEDA, CAL. The editor of the Spokesman is also the shepherd of this mission in the growing Los Angeles area. The congregation is in the midst of preparation for building a church. At present services are held in a rented hall. Enormous mission potential in this area. Winfred Schaller is the pastor.

HOLY CROSS, PHOENIX, ARIZONA. Michael Sydow is the full-time pastor. The congregation has a new church in a new housing area.

ST. STEPHEN, SAN FRANCISCO, CAL. This is the newest of our missions. There is a sizeable nucleus of Christians here to establish a congregation. The mission had been served by W. Schaller from Sepulveda, but since mid-September it is served by Rollin Reim.

ST. PETERS, DENVER, COLORADO. Pastor Daniel DeRose supports himself. The members and pastor urgently appeal for support that the pastor may spend full time in the work of the Church. Their House of Worship is a small remodeled house.

ROCHESTER, MINN. Pastor Harland Reed had been ministering to patients who had requested his services. In the fall of 1965 St. Peter's was organized as a congregation under the direction of Pastor Reed and with preaching help from seminary students. Pastor Reed is paid a token amount to defray at least in part, his expenses incurred in his work.

EMMETT, IDAHO. We have no mission here, but six families have requested the services of the CLC. If possible, we would like to see this field be given a period of exploration.

TAPE SERVICE: The Mission Board will provide sermons through this medium to those who wish them.

JAPAN. The work goes on in Japan's largest city. Missionary Tiefel reports that mission work is being done by members in another city, Shin-tokorozawa. The MB has resolved to invite Missionary and Mrs. Tiefel back to the states for a furlough this summer. An amount is placed into the budget each year to be set aside for furlough expenses every four years.

Missionary Tiefel has expressed the hope that Mr. Fujita, now living in New York State, will be able to attend the convention this summer. All would appreciate the first hand report of one of the members of the Japan church. Should our hopes be realized, time for a personal report from Mr. Fujita to the convention would be made available. (These hopes were realized. Ed.)

Printed material serves an important part in preaching the Gospel in Japan. Since there is a scarcity of usable religious material available the missionary must write, revise, and edit materials that can be used for children, for adults who meet with him and for those who require self-instruction manuals.

A copy of the revised catechism has been received and turned over to the proper board for review, as requested by the Japanese Christians.

At this writing three adult instruction classes are being conducted. There are 9 adults in one, 7 in another, and 3 in a third. Thus the work in Japan goes on . . . much like here in the states.

MEMORIAL OF THE WISCONSIN DELEGATE CONFERENCE

Dear Brethren:

After an intensive study of our C.L.C. Mission Report in the current Prospectus, and upon reflection of past mission activities and endeavors and methods, the Wisconsin Delegate Conference herewith presents the following memorial:

"Resolved: that the Wisconsin Delegate Conference memorialize the C.L.C. to activate a Standing Committee to study our stewardship of men and money, together with a thorough consideration of more adequate and up-to-date methods of communciations in our work of missions."

It is to be emphasized that this resolution in no way singles out the present or any previous Mission Board for censure, since our boards can only seek to carry out the body's directions, and have, in fact, done so under almost impossible financial conditions. The resolution rather aims at the thinking of the body, in large part inherited from previous synodical affiliations, that "walking in the old paths" includes the perpetuation of anitquated methods which do not seem to meet modern needs or administration.

As an example, what is to prohibit the C.L.C. from exerting our main financial efforts and investments in those mission areas in which sanctified Christian judgment reveals the greatest opportunities? Such action would necessitate serving those areas with little or no potential for growth and self-support on less than a full-time basis. In times past such areas were served by "circuit riders." A Standing Committee could inquire into the possibility of one man's serving a greater number of those less promising areas by more up-to-date methods, perhaps by plane, either commercial or private.

The Wisconsin Delegate Conference feels that the continued appeals of mission funds should be continued and expanded, but, at the same time, that continued efforts toward the wisest investments of such funds received could and should be facilitated by a Standing Committee assigned to reconsider regularly the best stewardship of men and money available coupled with the most up-to-date methods of serving "the widest area with the most for the least."

REPORT OF COMMITTEE # 4: MISSIONS

"My Word shall not return unto me void, but it shall accomplish that which I please and prosper in the thing whereto I send it." Knowing this, that the Lord adds to His Kingdom through the preaching of the Gospel, may we find renewed strength to fulfill the work which He has laid before us. After a careful study of the report

of the Board of Missions and in the best interest of carrying out our God-given commission to preach the Gospel, we ask that the convention make the following proposals and recommendations its own:

28

- I. We express our thankfulness to the Lord of the Church that He has given us two full-time missionaries in two new mission fields. We, however, must again repeat the fact voiced in the Committee Report on Missions at our last convention: "the fact remains that limited funds have prevented greater expansion of our mission program." We pray that the Lord will grant added zeal for missions to enable us to place additional full-time workers in other fields in the coming year. We are continually reminded of the many missionaries and pastors of congregations not under the supervision of the Mission Board (3 missionaries and 16 pastors), who are still doing secular work to help sustain the preaching of the Word.
- II. It brings us great joy to see in our midst at this convention our brethren from Japan, Pastor and Mrs. Tiefel and Mr. and Mrs. Fujita and daughter. We commend the Japan Church for its untiring zeal evidenced by its work of writing, revising, and editing printed material which serve such an important part in preaching the Gospel in Japan, in the revision of the catechism, which at the present time is being reviewed by the Board of Doctrine, and in the three classes in which nineteen adults are being instructed. We wish to encourage the Board of Missions to continue making a budgetary request each year for sufficient funds for a furlough for Pastor Tiefel every four years.
- III. Re: The Memorial of the Wisconsin Delegate Conference.

We agree with the memorial that there is need for special committee work. In the judgment of the floor committee, however, the subject matter indicated for such a study is too limited and already lies within the sphere of direct concern in the Board of Missions.

THEREFORE BE IT RESOLVED:

- A) That a committee of three be appointed by the president which will guide us in
 - 1) A critical appraisal of our church with regard to its general attitude toward the needs of those outside our membership; and
 - 2) A critical evaluation of the manner in which we are now employing our opportunities and resources to meet those needs.
- B) That the manner in which this study is made shall be left to the direction of the committee. It is hoped that the committee findings can be made a part of the program at the next regular convention.

REPORT OF THE BOARD OF TRUSTEES

The Financial Picture

We note with gratitude an increase in budgetary offerings of \$6,198.08 for the first nine months of the current fiscal year. For the same period, however, the offerings were \$11,751.06 short of the amount needed to fulfill all the commitments of the budget adopted by last year's convention. Despite this fact as of April 1 our cash deficit is \$2,884.92. The deficit would have increased by \$7,500.00 if this amount in the budget for payment on the land contract had been made.

Your board feels that in the interest of financial stability and orderly progress every effort must be made this year to draw up a budget in line with the realistic expectation of offerings. This should be done for two reasons: 1) there will be no item of \$7,500.00 of which we can defer payment; 2) as soon as the budget and offerings are equal, we can plan for orderly expansion on the basis of an anticipated increase in offerings. 29

Actions Taken

1. The debt limit has been raised from \$7,500.00 to \$10,000.00.
2. The name of the Japan Church Extension Fund has been changed to the Japan Emergency Fund.
3. The first professorage will be built this summer.
4. A 20-year mortgage loan of \$46,900.00 on the I.L.C. property has been negotiated at an interest rate of 5½% with prepayment privileges. This was done for two reasons: 1) to obtain title to the property and to remove it from the uncertainty of a land contract; 2) to reduce our debt retirement obligations while still leaving room for the speedy liquidation of this obligation, which we all desire. The payments under terms of the mortgage are \$323.00 monthly or \$3,876.00 annually.

Proposals for Consideration

We recommend:

1. That the repayment of indebtedness of I.L.C. be removed from the I.L.C. budget and that it be made a separate budgetary item, called Capital Investment;
2. That it be understood that the Board of Trustees, which is in charge of Emergency Support, also make provisions for the support of retired servants of the Word and their families.
3. That the gifts from the heirs of the Leila Nygaard estate in the amount of \$5,000 be applied to the cost of the construction of the first classroom unit.

The Chairman of your Board of Trustees wishes to bring the Board's report up to date by bringing the following to your attention:

The Financial Picture

We gratefully call attention to the following increase in offerings in the past fiscal year:

Actual offerings 1964-65.....	\$79,799.75

This represents a creditable increase in giving of 10%.

Nevertheless, these offerings failed to meet the budget to which we in the Fond du Lac Convention committed ourselves:

Budget for 1964-65.....	\$94,652.95
Offerings for 1964-65.....	<u>\$79,799.75</u>
Budgetary loss.....	\$14,853.20

As you may well expect the above figures had to produce a budgetary debt.

The budgetary debt as of July 1, 1965 was \$5,386.46.

We were spared the indebtedness of the full \$14,853.20 only because the debt payment of \$7,500 was not made to the Minnesota Foundation on March 1, 1965 and because various boards deferred necessary expenditures in the amount of \$7,353.10.

How the Financial Picture Relates to our Planned Expenditures for 1965-66: The Coordinating Council began its planning for the present fiscal year with a reasonable budget in terms of need of about \$110,000. After laboring long and hard with financial reality the budget was reduced to what the Council considered its lowest point without reducing salaries or curtailing either our mission or educational program any further.

The budget figure finally arrived at for 1965-66 was \$98,913.00.

Due to the budget debt of \$5,486.44 the convention must now deal with non-inflated financial needs of \$104,399.44.

The problem the convention faces is briefly this:

If we may assume another offering increase of 10% (which we believe a reasonable estimate without any other way of knowing what may be expected), our offering for 1965-66 would be \$88,000.

We would also remind the convention that there is no item of \$7,500 in the budget that can be deferred this year. Nor, without a doubt, can most of the deferred expenditures by the various boards be deferred one more year.

Your Board does not have the answer to our problem. It can only report the facts to you.

However, we feel that the convention must face up to fiscal responsibility 31
this year, or we face a financial crisis in the next 12 months that could stifle
the joy of our work in the Lord and will eventually lead to fiscal chaos. The
Board of Trustees has set a debt ceiling of \$10,000 and we are already rapidly
soaring toward that ceiling.

It is the personal judgment of your chairman of the Board of Trustees that it
is most difficult for representatives to vote a sound budget for a convention. Too
often, I believe, they vote according to their own feelings and desires to expand and
strengthen our Gospel preaching and teaching. I believe also that these representa-
tives personally support the budget that they vote. Yet, it is quite clear that
we are not voting the response of our respective individual congregations. I would
therefore ask each delegate to vote a budget on the basis of what increase we may
expect not from him, but from his congregation. And this, I know, will be no easy
judgment for the delegate to make.

Although I may be rightfully accused of repeating myself, I do believe that ways
must be found to develop congregational responsibility toward our joint work on
an increased and regular basis in our midst. The record following would indicate
to me that regular monthly responsibility on the part of congregations is not yet
very far along the way in our midst. The record will indicate one month in which
we receive \$2,781.58 and another in which we receive \$13,941.72.

That our financial goals are modest and well within our capabilities no one can
deny. Yet this does not alter the fact that the work of our congregations does
not seem to reflect an evident appreciation of the gift of grace that has been
given us by a gracious and long-suffering Lord.

Building Committee

Your Board of Trustees was appointed by President Albrecht to serve as Building
Committee. The Board of Trustees in turn appointed President Albrecht to serve
as overseer of the building projects to fulfill the functions of general con-
tractor. In order to lighten his load Board members Walter Romberg and Charles
Sandeem assumed responsibility for the new professorage.

As you have noted, I am sure, the classroom building is nearing completion. (It
has been completed and was dedicated September 26, 1965. Ed.)

We ought to bear in mind that this three classroom building is the first unit of
an educational complex. In order to satisfy the demands of the Industrial Com-
mission to remove the remaining classrooms from the boy's dormitory, plans for
the erection of another three classroom unit ought to be considered, so that we
are ready to proceed at a time when the convention deems proper and feasible.

The professorage was purchased from Capp Homes, erected on our foundation. It is to be hoped that with sufficient volunteer labor the home can be completed within a cost figure of \$14,000.

We were fortunate in securing a loan of \$14,000 from a C.L.C. member at an interest rate of 4 1/2%. The indebtedness will be retired from the rental allowance of \$100.00 a month. Monthly payments of \$88.58 will retire the indebtedness in 20 years. This will leave \$11.42 a month or \$137.04 a year for insurance and upkeep.

That we adopt a budget of \$100,000.00 for the coming fiscal year and that we respectfully ask the boards to readjust their budgets accordingly at the next meeting of the Coordinating Council. (Sept. 28, Ed.)

Committee report continues . . .

I. Actions Taken and Proposal Submitted by the Board of Trustees

1. We recognize the wisdom of the Board of Trustees' action in raising the debt limit from \$7,500.00 to \$10,000.00.
2. We agree to the change of the name "Japan Church Extension Fund" to "Japan Emergency Fund."
3. We are happy to note that the first professorage is in the process of being built.
4. We concur with the recommendation that the repayment of indebtedness of ILC be removed from the ILC budget and that it be made a separate budgetary item, called Capital Investment.
5. We concur that the Board of Trustees, which is in charge of Emergency Support, also make provisions for the emergency aid to retired servants of the Word and their families. However, we do not wish to inaugurate a pension program for the CLC.

II. Regular Offerings

We would emphasize again the importance of having all offerings, large or small, sent in to the Treasurer of the CLC every month.

We express our appreciation for the work of the Treasurer of the CLC in giving our membership a regular and detailed report of offerings. We also commend him and the auditing committee for their faithful efforts in carrying on this work of the Lord on our behalf.

REPORT OF THE LUTHERAN SPOKESMAN

At present the editorial offices and the typesetting are in Los Angeles, printing and mailing are done at New Ulm, subscriptions are handled at Madelia, and promotion is done out of Nicollet, Minnesota. This has resulted in too long a span in producing each issue. New arrangements are being made at the present time, which we hope will improve the efficiency.

Costs have risen considerably in the past few years. The printing of an issue has risen from approximately \$150 to over \$300 per issue. In the past year we operated at a deficit and used up the cushion that we once had.

We hope in a new setup to cut costs if possible. But there is also the possibility that production costs may increase if not handled by our Book House.

There is much that our congregations can do to help us in this situation. In recent years blanket subscriptions have been decreasing and individual subscription increasing. This increases costs considerably. We urge each congregation to adopt a blanket subscription plan and to designate a Lutheran Spokesman agent in their congregation who will communicate with our subscription manager. We also need a great increase in subscriptions and ask everyone to solicit them. 200 new subscriptions during this year would keep us operating in the black.

Our promotion work consists at this time in sending 100 sample copies each month to names submitted to the promotion manager. Post Office demands that Zip Codes be added to every 2nd class mailing. We ask cooperation in accomplishing this at once.

According to the report of the CLC Book House renewals have been holding up very well, including subscriptions from interested lay people. This has kept the circulation at about the previous figure of 200.

Printing cost have been somewhat higher than before, proving that the 1964 reduction of budgetary support (from \$500 to \$300) was too optimistic. We ask for a budgetary provision of \$400.

REPORT OF THE BOOK HOUSE BOARD

Having determined to operate without subsidy only a year ago and having had several changes in policy in the attempt to achieve that end, it is difficult to know how well the Book House is prospering on its own. It can be reported that at the end of September 1964 the net operating loss was \$633.01. By December 31, 1964 it had been reduced to \$193.41. While this is encouraging, it does point up the need for pastors and laymen alike to patronize the Book House whenever possible. The more business that the members of the CLC can bring it, the better it can serve the CLC.

Since the manager indicated he would be resigning, the Board has spent much time reviewing the Book House operations and considering possibilities for the future. After this consideration, it is the opinion of the Board that all areas of the Book House operations definitely should be continued in whatever way possible. There are two chief areas of operation - sales and publication. Both are valuable to the CLC. The sales department has an established credit standing and a dealership status with all major suppliers. It serves as a source of supply to the CLC for a wide range of merchandise at savings which, in many cases, could not be duplicated elsewhere. The printing department, likewise, serves the CLC. Recent inquiry has revealed that the Spokesman would cost considerably more if the work on it done by the Book House were done elsewhere. The cost of publication of the very limited numbers of the Journal of Theology by a commercial firm would be prohibitive. We would expect that the other printing presently done by the Book House for the CLC would cost more if done elsewhere.

We present no concrete suggestions to the Convention for the future operations of the Book House because there are still too many unanswered questions. There are a number of good reasons for continuing at New Ulm if it is agreeable to the congregation and its new pastor. It would save moving the equipment, buying new postal permits, disturbing customers with a change of address, and possibly, reincorporating in a different state. There is the possibility of separating the sales department from the printing and seeking a part-time operator for each. Perhaps it will become necessary to discontinue part of the operations temporarily, or permanently. We ask that the Convention trust the Board to adopt and implement a course of action which will enable the Book House to continue and grow in service to the CLC.
